Used Clothing Drive Beginning in October 2009 area law firms, corporations and other entities with ties to the Washington DC legal community have their employees donate used clothing. The clothing is collected by each participating entity and assembled at the organization's sorting site during the first weekend of December. Volunteers assist with the sorting of donated clothing, the fulfillment of clothing requests from area shelters and similar organizations, and the delivery of requested clothing to facilities. The entire process is completed during a 3 day period.

New Clothing Purchases The organization purchases socks, underwear, hats, gloves, sweats and other items from wholesalers and donates these items to Washington DC area homeless shelters and similar organizations. Donations are made during the late fall, in order to allow shelters to provide warm clothing to the homeless populations they serve. Funds for the purchase of such items are collected from individual and corporate donations made throughout the year, including during the Clothing Drive and a "Battle of the Law Firm Bands" contest each summer.
