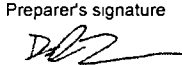

Part X, Line 2. Under the provisions of Section 501(c)(3) of the Internal Revenue Code, the Foundation is exempt from tax on income, except for unrelated business income. The Foundation had no unrelated business income for fiscal years 2011 and 2010, hence, no provision for income tax is required.

As of September 30, 2011, the Foundation had \$91,660 in net operating loss (NOL) carryforwards, which will begin to expire as early as fiscal year 2029 and as late as fiscal year

2031. The Foundation has not recorded a deferred tax asset for the NOLs since their realization is uncertain.

In accordance with ASC 740, Income Taxes, the Foundation evaluated its tax positions and determined that all are more-likely-than-not to be sustained on examination. Accordingly, there are no unrecognized benefits or applicable interest and penalties that should be recorded. The Foundation's tax returns for the fiscal years ended September 30, 2008, 2009 and 2010 are subject to examination by federal, state and local authorities.
