The Foundation is also the beneficiary of a local charitable trust that makes annual awards among the ten beneficiaries. In each of the years since the Charitable Trust's formation, the Kiwanis Club of Danville Foundation has received grants of varying sizes depending on the sole discretion of the Trustees for the Charitable Trust. The vast majority of the funds received are for designated projects in the community and the size of many of these grants skews the percentage of donations as compared to the total of all contributions; however, because of its broad support from the community and the fact that the Foundation has no control over the funding from the Charitable trust, we believe we are still a publicly funded charity and qualify as such.
