**ARTICLE VI
Fiscal Policy**

SECTION I - Each year the Executive Director shall prepare an operating plan and proposed itemized budget in format required from time to time by the Board for the upcoming fiscal year. The Executive Director shall submit said plan and budget to the Chairman at least one (1) month in advance of the upcoming fiscal year (ie. on or before September 1). The Chairman shall consult with the Executive Director regarding said plan and budget and shall finalize the format of said documents for presentation by the Chairman to the Board at the next regular or special called meeting. The Board shall have the sole and exclusive right to adopt, amend or reject the plan and budget. After approval and adoption of the plan and budget by the Board, if any significant changes arise (as defined hereafter) during the fiscal year, then the Executive Director shall notify the Chairman and submit a revised plan and budget to the Chairman. The Chairman shall consult with the Executive Director regarding said revised plan and budget and shall finalize the format of said revised documents for presentation to the Board at the next regular or special called meeting. For purposes of this section a "significant change" shall be defined as any proposed change of salary for any employee and/or any deviation of a line item amount on the budget in excess of \$1,500.00. The Executive Director shall abide by and comply with the operating plan and budget as approved from time to time by the Board.

SECTION II - In order to periodically analyze the Association's financial condition and to encourage and promote an ongoing dialogue and communication with the National Parks regarding requests for financial assistance, the Board shall establish the following procedures regarding the financial management of the Association: a) if possible, within two (2) months from each fiscal year-end (ie. on or before November 31) the Finance Committee together with the Executive Director shall review the financial statements and the proposed budget for the upcoming year and they shall report their findings to the Chairman; and b) thereafter within one (1) month (ie. on or before December 31) the Board shall convene to discuss the financial condition and to determine disposition of net gains, if any, of the Association; and, c) at least fifteen (15) days prior to the Board meeting the Executive Director shall notify the Park Superintendents and Chiefs of Interpretation in writing of the Board meeting; which notification shall invite them to attend the meeting and to submit written requests ("Park Requests") outlining a list of priorities (with monetary amounts and brief explanations) for funds requested to be disbursed to them by the Association; and, d) based upon the financial condition of the Association and the anticipated operating plan and proposed budget as discussed in Section I above and further based upon the information and input from the Parks, the Board shall determine a general plan of distribution of the net gains, which could include but not be limited to, future operational expenses, cash reserves, product development for the Parks and cash donations to the Parks, in addition to the in-kind services or non-cash donations. Some of the primary purposes of this procedure are to keep the Parks informed as to the financial condition of the Association and to furnish the Parks with a list of anticipated disbursements for the upcoming fiscal year.

The Executive Director shall advise the Parks that if they have any modifications, additions or deletions to their Park Requests, then they should submit same in writing for review and consideration by the Board.
