| CONSERVANCY OF SOUTHWEST FLORIDA WILDLIFE REHABILITATION CLINIC ORIGINALLY BUILT IN 1979 TO TREAT 400-600 ANIMALS PER YEAR, THE CONSERVANCY OF SOUTHWEST FLORIDA WILDLIFE REHABILITATION CLINIC NOW TREATS UPWARDS OF 2,200 ANIMALS A YEAR IN AN ANTIQUATED 1,500 SQUARE FOOT FACILITY IT IS THE ONLY FACILITY OF ITS KIND WITHIN COLLIER COUNTY AND RECEIVES NO GOVERNMENT FUNDING THE INJURED, SICK AND ORPHANED NATIVE WILDLIFE ARE TREATED BY A CARING STAFF OF THREE FULL-TIME EMPLOYEES AND SEASONAL INTERNS SUPPORTED BY A CADRE OF VOLUNTEERS WHO CLEAN CAGES, COURIER INJURED ANIMALS AND OFFER SUPPORTIVE CARE THE CONSERVANCY WILDLIFE CLINIC ALSO RELIES ON A DEDICATED GROUP OF VETERINARIANS IN THE COMMUNITY TO PROVIDE ADVANCED CARE WHEN IT IS NEEDED THE COST TO TREAT EACH ANIMAL EXCEEDS \$100 ANNUAL OPERATING EXPENSES FOR FOOD, MEDICAL SUPPLIES AND STAFF AVERAGE \$250,000 INCREMENTAL OPERATING COSTS ARE SUBSIDIZED BY COMMUNITY PARTNERS WHO SOMETIMES DONATE BASIC FOOD NEEDS FOR THE ANIMALS THE WILDLIFE CLINIC RELEASES ABOUT HALF OF THE ANIMALS TREATED BACK INTO THEIR NATURAL HABITATS |                |         |                        |               |          |
