THE PALM BEACH COUNTY CULTURAL COUNCIL IS THE DESIGNATED LOCAL ARTS AGENCY FOR PALM BEACH COUNTY AND AS SUCH MANAGES PROGRAMS FOR THE COUNTY INCLUDING GRANTS TO THE CULTURAL INDUSTRY AND PROMOTIONAL ACTIVITIES. FUNDS FOR THESE PROGRAMS ARE LARGELY DERIVED FROM THE COUNTY'S BED TAX, AND THE COUNCIL HAS MANAGED THESE CULTURAL PROGRAMS FOR MORE THAN 29 YEARS, GRANTING MORE THAN \$150 MILLION TO DATE.
