The Sharing Center provided assistance to 12,458 families in fiscal year 2010-2011. 9,945 families received food; 5,804 families received clothing; 5,310 families received medical assistance; 731 families received shelter assistance; 719 families received utility assistance; 174 families received transportation assistance; and 1,592 shoe gift cards were handed out at all events.

Thrift store - During fiscal year 2010-2011, the thrift store sales totaled \$479,131, which proceeds were used to further the mission of The Sharing Center.
