The Food Bank was established in Gainesville in 1987, and has worked tirelessly to get food to the plates of the hungry and food insecure. During FY 2010-11 the Food Bank distributed 4,103,419 pounds of food - a new record! We serve the north central Florida area - including Alachua, Dixie, Gilchrist, Lafayette, & Levy counties. We do this primarily through our network of 150 agencies who serve on the front lines of poverty in soup kitchens, food pantries, faith-based and community feeding and food programs. Bread of the Mighty is the area administrator for the US Department of Agriculture (USDA) The Emergency Food Assistance Program (TEFAP), commonly known as "commodities." USDA commodities are distributed through 31 agencies.

4b (Code:) (Expenses \$ **473,262** including grants of \$) (Revenue \$)

The Kids Cafe Summer Lunch Program was established at Bread of the Mighty in September 2007 to provide free meals to children in Gainesville and the surrounding areas. Kids Café sponsors the Dept. of Educ. Summer Food Service Program. Summer can be a very hungry time for children who normally rely upon school breakfast and lunch programs to get the food they need to sustain their growing bodies and minds. In Summer 2011 we had 25 sites serving lunch, as well as either a breakfast or an afternoon snack. These sites operated in some of our neediest neighborhoods. In the course of 10 weeks 23,440 breakfasts, 10,251 snacks and 46,008 lunches were served.

The Kids Cafe Snack Program was established at Bread of the Mighty in September 2007 to provide free after school snacks to children in Gainesville and the surrounding areas. Kids Café sponsors the Florida Department of Health Child Care Food Program. This program provides free after-school snacks through a network of 14 sites serving approximately 650 children each week throughout the academic school year. Program sites provide after-school care and tutoring to children in neighborhoods where the servicing school has a 50% or higher eligibility rate for free & reduced lunch programs. Through Kids Café these children are receiving critical and nutritious snacks while attending the after-school programs.

In prior years, the Food Bank did not account for the mortgage discount that the Lender, the Gainesville Community Foundation, Inc. had set forth. Management has determined that this transaction should have been recorded. Accordingly, these financial statements include a prior period adjustment in the amount of \$227,429 - the balance of the mortgage discount at September 30, 2010.

In addition, the Food Bank recorded inventory values at \$0.05 per pound for donated food. Feeding America, Inc. suggests using \$1.66 per pound. Management determined to value food equal quality to the purchased food at the same value per pound. That value was calculated at \$0.78 per pound. Management also determined that donated food was slightly less quality as purchased food; therefore, they determined to value donated food at \$0.68 per pound. Accordingly, these financial statements include a prior period adjustment in the amount of \$155,567 - the balance of the prior year inventory valued at the newly determined poundage rates.

In addition, the prior year tax return was completed prior to the audit. The difference between the prior year tax return net assets and the prior year audit decreases net assets by \$13,522.

The total prior period adjustment was an increase to net assets for the year ended September 30, 2010 in the amount of \$369,474.
