The U.S. Space & Rocket Center Foundation is a 501(c)(3) organization, which supports the educational programs of the U.S. Space & Rocket Center and SPACE CAMP, through grants, fundraising, scholarships, and corporate sponsorships.

Through the fundraising efforts of the Foundation, donations are made and allocated to the U.S. Space & Rocket Center for scholarships to attend Space Camp and other educational museum programs. Space Camp and affiliated programs provide hands on learning of Science, Technology, Engineering, and Math (STEM) in an immersive setting using Space Exploration as the theme and back-drop. This same technique is applied in our educator programs and not only teaches our educators but provides learning tools they can take back to the classroom. In FY11 404 teachers received scholarships to attend Space Academy for Educators, and 551 students were scholarship recipients. Based on restrictions established by donors, travel expenses are often covered by the scholarship funds as well. 4b (Code:) (Expenses \$ **0** including grants of \$ **354,823**) (Revenue \$ **0**)
The Foundation granted donations to the U.S. Space & Rocket Center to fund additional museum exhibitions. During the fiscal year the museum hosted two traveling exhibitions. The first was CSI: The Experience. This exhibit immerses the guests in hands-on science while leading them through the challenge of solving a crime. The next exhibit to be offered to the museum guests was Sue and Be the Dinosaur. This traveling, bilingual exhibition combines science, education, and great appeal to present the story of the largest, most complete Tyrannosaurus rex ever unearthed and the content connects with visitors of all ages and abilities. Permanent exhibits completed during the reporting year included an Apollo Mission Patch Display hi-lighting the unique crests of each of the 12 Apollo Missions, and the 3 Skylab Missions; and a mock-up of the Instrument Unit that was the guidance component of the Saturn V Moon Rocket. This exhibit is a great addition to the other artifact-rich exhibitions at the U.S. Space & Rocket Center. In FY11 the museum hosted 213,243 museum guests and 23,606 Space Camp program attendees.

4c (Code:) (Expenses \$ including grants of \$ **206,533**) (Revenue \$)
The Foundation solicited funds from corporate and private donors to sponsor several major events throughout the year. The first event took place in February and our guest, Neil Armstrong, presented a lifetime achievement in Education award to Rocket Scientist Georg von Tiesenhausen. http://blog.ai.com/breaking/2011/02/neil_armstrong_1.html. In April we hosted the Great Moon Buggy Races which had 70 teams of High School and College students from 22 states and Puerto Rico. This contest challenges students to tackle many of the same engineering challenges dealt with by Apollo-era lunar rover developers in the late 1960's. The event sponsorships for the year also included the Space Exploration Celebration and the 4th Annual Space Camp Hall of Fame dinner. The total attendance for all of the events was in excess of 1,000 people. The events were all hosted by the U.S. Space and Rocket Center but underwritten by funds raised by the Foundation. These events support the missions of the Foundation and keep the community at large engaged and up to date on what is current in the Museum.
