Per MNF's 2011 strategic plan, the Foundation successfully completed its goal of offering and awarding a \$1,000 scholarship to each school of nursing in Mississippi. In addition, the Foundation has awarded \$60,000 in stipends to nursing students and nurses through the car tag program. For the first time, the Foundation awarded three research grants to support graduate students in their research efforts. Grant funding has allowed the Foundation to expand its services to sponsor 30 nurses at MNA's Centennial Convention, teach nursing students about tobacco cessation, promote nursing as a career in the Delta, and teach school children across the state about infection control. This expansion of services has been achieved while continuing the core programs of student stipends and continuing education.
