Summer Experiential Education Programs - each student receives two full scholarships to life-changing summer experiential education programs, including wilderness leadership expeditions, academic enrichment programs, community service, and home-stays abroad. These programs enable students to push themselves and succeed beyond what they think is possible physically, emotionally, and intellectually.

Weekly Mentoring - full-time staff mentors work one-on-one with students, providing holistic support and challenging students to gain greater self-awareness and accept responsibility for their growth and academic success. Through mentoring, students build a trusting and enduring relationship with an adult, some for the first time in their lives.

The Organization provides a comprehensive training program to staff in order to develop and improve mentoring skills which can help students develop relational, leadership and resiliency skills.

Training is conducted year-round through a series of intensive workshops delivered in person by highly-trained staff and youth development experts.
