 The organization provides counseling to pregnant women regarding prenatal and parenting issues to assist mothers in making the best decisions for their children. The organization assists birth mothers with medical costs, transportation to and from doctors appointments, food, toiletries, and other living expenses. For birth mothers who choose adoption, the organization places the adoptive children in safe, stable, and loving homes. The organization receives adoption fees from adoptive parents, including application fees, home study fees, and placement fees. For birth mothers who choose to keep their babies, the organization provides them with counseling and links them to other agencies that provide assistance. For the tax year ending September 30, 2011, the organization received calls from seventy-five pregnant women and worked on a continuing basis with twenty-eight of those women. Seven babies were placed for adoption during this period.
