AKILI DADA, Nairobi, Kenya - Akili Dada invests in the empowerment of brilliant young women from impoverished backgrounds who have demonstrated their commitment to social change by serving their communities. Their investment includes access to high-quality secondary education through comprehensive scholarships, personalized mentoring, and leadership development grounded in community service, as well as continued support through the university level and beyond. Accomplishments include 23 young women in secondary school were supported with full scholarships, including 8 students new to the scholarship program. An additional 8 students benefited from the mentoring program, in addition to those on full scholarships. Akili Dada high school alumnae were on full scholarships to universities in Kenya and the U.S. An additional 5 scholars graduated from high school with scores high enough to earn full university scholarships. Akili Dada women leaders carried out 31 different community service projects serving hundreds of people in 30 communities across Kenya. 30 Kenyan women professionals volunteered as active mentors to scholars and alumnae.

ST VINCENT'S DE PAUL COMMUNITY DEVELOPMENT ORGANIZATION, Kibera, Nairobi, Kenya - St Vincent's works in the slum of Kibera to address the root causes of poor children's vulnerability by providing opportunities for education, housing and care, and economic opportunities for mothers. Accomplishments include providing nursery education, two daily meals and school uniforms to children between the ages of 3 and 7 through the St Vincent's Nursery School, which currently serves 78 young children who would otherwise not have a place to go during the day while their parents are working. In addition, the St Vincent's Rescue Center provides shelter, food, clothes, schooling and medical support to 17 children between the ages of 6 and 17 who do not have a guardian or those that have been affected by abuse. St Vincent's also currently supports 20 single mothers to run businesses in the community and supported 23 children and 5 parents to access medical treatment in the last year.

JAGRA VIHARA (Hospital for Hope) Jharkand, India - Jagriti Vihara has been working since 1975 to empower the rural poor to play an active role in strengthening society. The Hospital for Hope project has raised \$100,000 through One World Children's Fund to build a functioning clinic & hospital that will serve 100,000 people who were previously without a local hospital. Construction materials are currently being purchased and the hospital is due for construction in summer 2012. The clinic & hospital will provide complex medical procedures such as surgeries, and health education and preventive campaigns around topics such as malaria.
