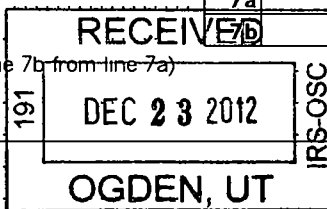

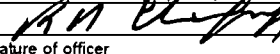

Maintenance and improvement items include the installation of a drop roof ceiling in the transition house and painting of a girls dorm facility.
