The Festival has analyzed tax positions taken for filing with the Internal Revenue Service and Idaho State Statutes. The Festival believes that income tax filing positions will be sustained upon examination and does not anticipate any adjustments that would result in a material adverse affect on the Festival's financial condition, results of operations or cash flows. Accordingly, the Festival has not recorded any reserves, or related accruals for interest and penalties for uncertain income tax positions at September 30, 2010.

The Festival is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any periods in progress. The Village believes it is no longer subject to income tax examinations for years prior to 2006.

The Festival's policy is to classify income tax related interest and penalties, if any, in interest expense and other expenses, respectively.
