Federally funded energy assistance served 6,432 households, privately funded energy assistance served 4,568 households, emergency food assistance provided support to rural food banks to serve 2,969 households, temporary food assistance provided resources to food banks serving an average of 8,984 households per month, temporary food assistance provided resources to feeding sites serving an average of 1,040 individuals per month, weatherization and minor home repair performed weatherization to 487 households, basic (non-power) utility assistance was provided to 81 households, weatherization training was provided to 118 individuals, benefits coordination provided information on how to access additional services to 1,368 individuals

Family Service Programs - These programs include the Monarch Children's Justice and Advocacy Center which served 688 individuals, Rental Assistance served 77 households, Family Development maintained a case load of 1 family per month, Women, Infants, and Children served an average of 3,074 women, infants, and children per month, the Mason Dental Clinic, in partnership with the Mason County Dental Coalition, provided dental services to 1,212 patients, and, the information & referral system provided over 22,000 units of referral. Funding for these programs comes from various sources including USDA Women, Infants, and Children (WIC), Community Development Block Grant (CDBG), and the Community Services Block Grant (CSBG)
