WOMEN'S WELLNESS PROGRAM - Another area of special concern for us is case management Guests are helped to work their way through complicated systems requiring phone, computer, and paperwork In this way, our social worker and social worker interns help our guests to move in very positive ways toward self-sufficiency Self-sufficiency builds self-esteem, and our individual and group counseling and other small groups such as writing, yoga, budgeting, domestic violence, and others assist in this process We work in collaboration with other agencies so as not to duplicate services When available we distribute feminine hygiene products and toiletry bags We are also privileged to have the assistance of nursing, child development and human resource interns at various times during the year We also provided 832 hours of one-one counseling with our Social Worker In these ways we continue to build on our holistic approach to our guests' lives
