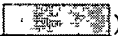
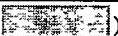
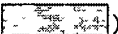

During the FY '11 Artadia focused resources and programming on a series of ambitious exhibitions, dialogues and a comprehensive publication that featured the Artadia Awardees from Atlanta, Boston, Chicago, Houston and the San Francisco Bay area from program years of 2008-2009.

Five exhibitions were hosted in partnership with organizations in each city and artists from Boston showed in San Francisco, San Francisco artists exhibited in Atlanta and so on. With each exhibition, there was a dialogue and a series of programming always open to the public. Partner organizations for the exhibitions included DiverseWorks, Hyde Park Art Center, Mills Gallery at the Boston Center for the Arts, Walter & McBean Gallery at the San Francisco Art Institute, and the Atlanta Center for Contemporary Art. Curators conducted studio visits with the exhibiting artists in each city, and organized the exhibitions in collaboration with Artadia's staff. In conjunction with the series of exhibitions, Artadia produced a 164-page full color catalog that featured the artwork and biographies of recent Awardees. The publication was distributed around the country and was well regarded. Franklin Sirmans, Curator of Contemporary Art at the Los Angeles County Museum of Art was the guest-editor of the book.

In FY'11, thanks to continued support from the National Endowment for the Arts, the Orentreich Family Foundation, and Pollock-Krasner Foundation as lead supporters, Artadia continued its third year of the Artadia Artist Residency Program in Brooklyn, NY in collaboration with the International Studio and Curatorial Program. Within the fiscal year, four artists from around the United States were in residence for three months each, and were also provided with a living stipend, a materials stipend, a
