Youth Art Program - this program provides year-round arts programming, in the form of music, dance, visual arts, media, culinary arts, organic gardening, and field trips, for at-risk youth, ages 5-19, that live in low-income neighborhoods and public housing communities throughout Seattle and King County, WA. Programming is held during both out-of-school time hours as well as in-school time 50 weeks per year. In fiscal year 2011, 2,295 youth were served with 1,346 classes totaling 2,320 program hours and 20,880 participant hours at 15 sites.

4b (Code ) (Expenses \$ 147,023. including grants of \$ ) (Revenue \$ 450.)

Urban Forest Restoration Project - this is a long-term, on-going habitat restoration, stewardship, and education project in the West Duwamish Greenbelt (WDG), which is the largest remaining contiguous forest in Seattle. The WDG is an important ecological resource for the entire King County region and is home to wide range of bird species and wildlife and provide recreational opportunities for the region's residents. In fiscal year 2011, 3,651 volunteers were engaged in 161 volunteer work parties and 10,557 hours of service, and 1,684 hours of education. During this time, 3,335 native trees and 3,820 native shrubs and understory were planted, tons of invasive vegetation was removed from 627,027 square feet of forest, and over 60 acres were maintained and stewarded.

Arts in Nature Festival - an annual community festival which encompasses music, dance, theatre, aerial and fire performances, interactive arts activities, outdoor art installations, and a museum of sound comprised of multi-media sound installations in 8 rustic cabins throughout the park. The festival is hosted at Camp Long in West Seattle and during fiscal year 2011 the event engaged over 3,000 festival attendees, 30 volunteers and 145 local musicians and artists in 43 performances, 9 sound installations and 4 interactive arts areas.
