OUTREACH AND INFORMATION: ARCUS serves as a communication channel providing information about current research activities and arctic issues to the scientific community, agencies, and the public. ARCUS finalized and released several issues of Witness the Arctic which is a newsletter that provides information on current arctic research and education efforts and news, significant research initiatives, national policy affecting arctic science, research support and logistics, profiles of institutions with major arctic research efforts, and calendar events and publications. The ARCUS website provides essential information and resources for the diverse and geographically distributed arctic research community. ARCUS continues to develop and maintain the online Arctic Calendar. The online calendar provides an up-to-date and comprehensive calendar of arctic meetings and conferences. ARCUS continues to develop and maintain ArcticInfo, the primary electronic mailing list for the arctic research community. ArcticInfo provides timely information about funding opportunities, important events, publications, position announcements, and other news. The Directory of Arctic Researchers was initiated in 1994 to facilitate networking and collaboration in arctic research and education efforts between individual investigators, institutions, funding agencies, and arctic stakeholders. ARCUS continues to conduct a number of outreach activities that disseminate timely information.

ARCTIC LOGISTICS AND COMMUNITY SCIENCE PLANNING: These activities coordinate science planning for the arctic research community across disciplinary and organizational boundaries; includes Study of Environmental Arctic Change (SEARCH) Coordination, and final State of the Arctic Conference product development. The major SEARCH related activities were leading the SEARCH Science Steering Committee (SSC) in a strategic planning process; development of the Understanding Change Task Force report; facilitation of the Observing Change panel activities, including planning for a U.S. AON Coordination meeting; and managing the Sea Ice Outlook and Sea Ice for Walrus Outlook projects. ARCUS began a strategic planning process in 2010 to define a clear long-term vision and goals to move SEARCH to a fully implemented interagency program. ARCUS worked closely with the SCC and NSF, providing leadership and making significant strides in the process. ARCUS continued to work with several collaborators on final State of the Arctic conference products. These products included a brochure summarizing societally-relevant conference highlights for policymakers, a science highlights paper, and a paper focused on the human dimensions science of the conference.

NOTES TO FINANCIAL STATEMENTS

1. ORGANIZATION AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Organization

The Arctic Research Consortium of the United States, Incorporated (ARCUS) is a nonprofit membership corporation exempt from income tax under Section 501(c)(3) of the Internal Revenue Code and is not a private foundation. ARCUS was formed in 1988 to serve as a forum for planning and facilitating studies of the Arctic, to synthesize and disseminate scientific information relevant to arctic research and to facilitate the education of scientists and the public in the opportunities of research in the Arctic. ARCUS consists of fifty institutions organized and operated for educational, professional, or scientific purposes. Its revenue is primarily from a Cooperative Agreement with the National Science Foundation (NSF).

Basis of Presentation

ARCUS has adopted FASB ASC 958 which establishes standards for external financial reporting by not-for-profit organizations and requires that resources be classified for accounting and reporting purposes into three net asset categories (unrestricted net assets, temporarily restricted net assets, and permanently restricted net assets) based on the existence or absence of donor-imposed restrictions.

Method of Accounting

The accounting records are maintained on the accrual basis of accounting. Revenues are recognized when earned and expenses are recognized when incurred.

Cash Equivalents

ARCUS maintains a checking and savings account with Wells Fargo Bank, NA. For the purposes of the financial statements, ARCUS considers all liquid investments having initial maturities of three months or less to be cash equivalents.

Receivables

Receivables include amounts due from funding sources, employees and others. When management determines that a receivable is uncollectible, the balance is removed from the receivables balance and is charged to bad debt expense. Management believes that all receivable balances are fully collectible at September 30, 2011 and 2010.

Property and Equipment

Property and equipment purchased by ARCUS, with an acquisition cost of \$5,000 or more, is recorded at cost and is capitalized and depreciated over its estimated useful life of two to five years, using the straight-line method. This furniture and equipment is the property of ARCUS. Major equipment purchased under the Cooperative Agreement is capitalized and is the property of ARCUS. Depreciation expense in the amount of \$3,730 and \$4,160 was recorded for the years ended September 30, 2011 and 2010. Minor equipment purchased under the Cooperative Agreement is expensed and is the property of ARCUS.

1. ORGANIZATION AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES, CONTINUED

Accumulated Unpaid Annual Leave

Accumulated unpaid annual leave benefits are accrued and charged to expense in the period earned by the employee.

Income Taxes

ARCUS adopted FASB ASC 740 *Accounting for Uncertainty in Income Taxes* that requires ARCUS to recognize a liability for uncertain tax positions where a liability would more likely than not be assessed by a taxing authority. Management has evaluated ARCUS' tax positions and determined there are no liabilities required to be recognized as the result of an uncertain tax position. Tax years 2007 through 2010 remain subject to examination by the federal Internal Revenue Service.

Management's Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Functional Allocation of Expenses

The costs of providing the programs and other activities have been summarized on a functional basis in the statement of activities. Accordingly, expenses that benefit both programs and supporting services have been allocated using management's estimates.

Subsequent Events

Management has evaluated subsequent events through January 4, 2012; the date financial statements were available to be issued and identified there were no subsequent events that required accrual or disclosure.

2. NSF COOPERATIVE AGREEMENT

On March 15, 2008, NSF entered into a new 5-year cooperative agreement with ARCUS with an estimated value of \$10,298,522, including supplements. The approved funding as of September 30, 2011 is \$6,795,657 which covers the period from April 1, 2008 through December 31, 2011.

4. RETIREMENT PLAN

ARCUS has a defined contribution ("money purchase") plan established by the Board of Directors. The plan operates under section 403(b) of the Internal Revenue Code. ARCUS is the administrator of the plan. The plan year is from October 1 to September 30. Under provisions of the plan, employees are eligible to participate immediately upon their employment regardless of hours worked. The fund sponsors and funding vehicles are provided by Teachers Insurance and Annuity Association (TIAA) and College Retirement Equities Fund (CREF). Costs under the plan totaled \$52,316 and \$47,431 in 2011 and 2010, respectively.

5. LEASE COMMITMENTS

In March 2001, ARCUS began leasing its administrative office space under an operating lease agreement. Over the years the lease has been amended to add/delete office and storage space and to modify the monthly payment amounts. In March 2009, the office operating lease was amended to decrease ARCUS' occupancy space. In August of 2010, ARCUS modified the lease agreement to reflect that it no longer required the storage space in the basement. The lease expires on February 28, 2013. Total expense charged under this lease was \$131,640 and \$150,840 in 2011 and 2010, respectively.

In July 2009, ARCUS renewed the lease agreement for office equipment which requires 51 monthly payments of \$97. Total expense charged under this lease was \$1,164 and \$1,164 for 2011 and 2010, respectively.

We have audited the financial statements of Arctic Research Consortium of the United States, Incorporated (a nonprofit organization) as of and for the year ended September 30, 2011, and have issued our report thereon dated January 4, 2012. We conducted our audit in accordance with auditing standards generally accepted in the United States of America and the standards applicable to financial audits contained in *Government Auditing Standards*, issued by the Comptroller General of the United States.

Internal Control Over Financial Reporting

In planning and performing our audit, we considered Arctic Research Consortium of the United States, Incorporated's internal control over financial reporting as a basis for designing our auditing procedures for the purpose of expressing our opinion on the financial statements, but not for the purpose of expressing an opinion on the effectiveness of the Arctic Research Consortium of the United States, Incorporated's internal control over financial reporting. Accordingly, we do not express an opinion on the effectiveness of the Organization's internal control over financial reporting.

A *deficiency in internal control* exists when the design or operation of a control does not allow management or employees, in the normal course of performing their assigned functions, to prevent, or detect and correct misstatements on a timely basis. A *material weakness* is a deficiency, or a combination of deficiencies, in internal control such that there is a reasonable possibility that a material misstatement of the entity's financial statements will not be prevented, or detected and corrected on a timely basis.

Our consideration of internal control over financial reporting was for the limited purpose described in the first paragraph of this section and was not designed to identify all deficiencies in internal control over financial reporting that might be deficiencies, significant deficiencies, or material weaknesses.
