The Tuality Healthcare Foundation (THF) exists to support and assist Tuality Healthcare in fulfilling its mission. The Foundation's purpose is to acquire and manage philanthropic contributions. We direct these funds to medical and health education projects and programs that we believe will advance our community's physical and mental quality of life.

A maximum of 25-member volunteer Board of Directors governs the Foundation. As of fiscal year end, there were 19 active members and 3 Emeritus. Executive Committee, consisting of Board Chair, Vice-Chair and Secretary Treasurer, decided to hold vacant positions open in the short term. This decision was made as we are in a transitional time between major fundraising campaigns.

Total contributions to the Foundation for the fiscal year totaled \$1,109,940. Primary sources of revenue were proceeds from several fundraising events including the iSalud! The Premier Oregon Pinot Noir Auction, the Annual Dinner Dance and the cancer 5k – The C.A.T. Walk and Fun Run. Other sources of revenue include solicited and unsolicited gifts to our many funds as well as to our Digital Mammography Campaign. During the summer of 2001, we reached our goal of raising \$900,000 for digital mammography and are excited to see the new Women's Breast Health Center open in mid November 2011. We also worked hard to collect the final outstanding pledges to the Cancer Center Campaign which began in the year 2000. In September of this year we collected the final pledge to bring the grand total collected to \$2,364,150.

Activities of the Foundation are highlighted below.

Endowed and Non-endowed funds comments

Total Endowed and Non-endowed Funds experienced a gain on investments earnings of \$61,838 for the twelve months ended 9/30/11. In addition, Unrealized Losses totaled \$83,786. While these results are not quite as strong at fiscal 2010, they are similar results to fiscal 2009 and yet are still significantly better than the losses of over \$529,000 in 2008. In April 2009 we dropped the maximum allocation of funds in equities (vs. bonds and cash) to be lowered from 70% to 60% to be a little more conservative. We also reduced our Spending Formula from 6% to 5% (of the three year average of the ending fund balances of the Endowed Funds). Both of these changes will remain in affect until further notice, even though they continue to negatively impact several of our projects in terms of reduced funding (Scholarships, Community Education, and THIRC).

As defined in the Foundation's Investment and Spending Policy and by donor designation, investment earnings were used to support the following areas:

- general hospital support
- the DeMar Batchelor Memorial Health Education Lecture Series
- Scholarship programs
- other community education programs and support groups offered at the Tuality Health Education Center the Tuality Health Information Resource Center
- upkeep, renovation and special projects of the Tuality Health Education Center
- the iSalud! outreach program

Community Education

The Foundation manages endowments which fund and support free health education services to the community, particularly focusing on diseases where early intervention significantly improves quality of life. Most of the Support Groups that the Foundation supported in the past were continued this year: Weight Management, Breastfeeding , Diabetes and Insulin Pump, Tobacco Cessation, New Parents Monday and Toddler Time, and Living Well with Chronic Conditions. (Through partnerships with other organizations, Community Education also hosts support groups for Spanish Childbirth and Spanish Diabetes (Virginia Garcia clinic), Alzheimers (Alzheimer's Association), Brain Injuries, Depression (National Association for the Mentally Ill), Family Caregivers (Misty Mountain Counseling), and Coping with Grief and Loss (Washington County Hospice). A new Chronic Pain Support Group commenced this month in partnership with the Oregon Pain Society. Two new classes were introduced as pilot projects this past year. An Arthritis and Movement class, taught by an instructor from the Arthritis Foundation, and a Tobacco Cessation class sponsored in partnership with Pacific University, were held in the spring. These two popular classes will hopefully be held again this coming year.

Foundation-sponsored scholarships for Diabetes, Living Well with Chronic Conditions, Tomando, Childbirth and Tobacco Cessation for this past year totaled over \$6,000. This is a higher total than we have experienced for several years. It is both a reflection of the greater need in our community and better connections between health organizations and Community Education in partnering to serve residents in the Hillsboro area. NW Parish Nursing, Providence Healthcare, Virginia Garcia Clinic, Washington County Department of Aging, Tuality Healthcare Alliance and Pacific University have all worked with Tuality Community Education to help provide services to patients in the community so that scarce funding is not wasted providing duplicate services. Almost 3 times as many Living Well and Tomando classes were

held in the past year as had been planned, a direct result of several of the partnerships that developed over the year.

Evening Chats and lunchtime Brown Bags have received excellent attendance this year as they focused on topics of major interest to patients, including Pain Management, Congestive Heart Failure, Stroke, Diabetes and the well attended Cooking Classes with Shelie Hartman-Gibbs, one of the hottest ticket items at Tuality. Shelie brings in her "Friends" to help put the class on, ranging from fellow Tuality employees to vineyard cookbook pros. These programs are taped by local cable television, shown on cable television, viewed online on YouTube, and checked out from local public libraries.

Tuality Car Seat Clinics have grown in number from 4 to 12 per year, taking place on the second Saturday of each month. Up to 50 individuals are helped in each 2 hour car seat clinic as the registered technicians make sure that the seats are the right size and attached correctly into the car. This clinic is held in partnership with Safe Kids of Washington County, which supplies the car seats. Foundation funds provide personnel, education and other supplies.

Coming up next year will be a move to online childbirth education classes, more Cooking Classes with Shelie, classes for children with diabetes sponsored by Tuality Health Alliance, more Diabetes in the School classes sponsored by the City of Hillsboro, a Breast Health Awareness Women's Tea partially sponsored by Susan G. Komen Foundation, a new Advanced Diabetes Education class, and revamped Weight Management classes and Diabetes Support Groups.

Scholarships

Scholarships are granted to employees throughout the fiscal year by (THF). The scholarship committee, which conducts scholarship interviews on a quarterly basis, consists of seven individuals, mostly Foundation Board Members, and is chaired by Dr. Anthony Hoffman. This year, educational scholarships totaled \$34,260 and were awarded to 46 Tuality employees pursuing health-related education or certification. Funding for these scholarships come from generous donations from the community and from the following funds: "Well Into the Future" Endowment, R.E. Hutchinson M.D. Health Scholarship Fund, Helen Schoen Scholarship Fund, Jane Kay Pitts Nursing Scholarship Fund, the Judy Browning Memorial Scholarship and the Volunteer Services Department Scholarships Fund.

Scholarship awardees varied by department, from Diagnostic Imaging, Physician Billing and iSalud! Services, from Security to Rehabilitation Services. This year employees attended various seminars, workshops and conferences including evaluation and treatment of the shoulder, medgraphics cardiorespiratory diagnostics,

and cytology to name a few. Others took courses for a Masters degree or updated certifications by taking continuing education courses within their field.

In addition, the Flo Rhea scholarship is an annual scholarship granted to a high school senior who is seeking a future in a health-related field. Since the inception of the Flo Rhea scholarship in 1993, 21 high school students have received assistance amounting to a total of \$31,800.

Special Events

The 19th annual iSalud! The Premier Oregon Pinot Noir Auction was held in November 2010. The two-day event generated \$648,008, up from \$608,160 the prior year. For a number of reasons, including a struggling economy and fewer guests, the last two years represent drops from the prior three years where the auction grossed well over \$700,000 each year (2007-2009). This recent drop in revenue, however, was bolstered by the Supporters Program which provides a variety of methods to generate income through tasting room fees, percentages of bottles sales, and mini "special events" through out the year, to name a few. During fiscal 2011, these "other gifts" totaled approximately \$71,000, a number that is expected to grow as more wineries join the Supporters Program.

These fund-raising efforts support our iSalud! Service program, which continues to expand the number of wineries and clients helped with both medical and dental needs. For the past three years, the total revenues generated from efforts mentioned here did not in fact cover the expenses of the expanding service program – shortfalls were covered by excess funds from prior years. As liquid funds have been depleted, we know that this shortfall cannot be sustained and we very possibly will have to look at cutting back the clinical side this next fiscal year. A final decision will not be made until after results come in after this next November's event. Staff and committees are working to develop a plan to cut back certain services if the event falls short of projected needs.

The 26th annual Dinner Dance event entitled "Celebrate Pink, a toast to our new Breast Health Center" was held January 29, 2011. This black-tie event was held at the Tuality Health Education Center and was attended by 194 guests. Dinner was catered by Jake's Catering and Swingline Cubs band played dancing music throughout the evening. This event generated over \$64,000 for the current digital mammography campaign.

The 11th annual C.A.T Walk was held on the July 4, 2011 in downtown Hillsboro. This year the number of walkers/runners was over 1,200. This was a 9% participation increase over 2010. The kids' zone was a hit with a jump house, carnival games and a clown. The nearly \$67,000 raised will also contribute efforts to bring digital mammography to Tuality.

We again decided to hold off on reinstituting the annual Tuality Putt N' Pray Golf Tournament due to the uncertain economic downturn and the effect of decreased sponsorship participation. This event may be considered for the upcoming fiscal 2012.

Employee Campaign

2011 represented the second year of the two year bi-annual employee campaign; results reported are on a calendar end, not fiscal as are all other parts of this report. This campaign will end 12/31/11. The Foundation held a week long event to promote the campaign. Departments created baskets that individuals could purchase raffle tickets at a chance to win a basket and a silent auction was also held. Estimated total funds raised, including pledges, is \$139,196 from employees, medical staff and the local community. Of this amount, \$122,313 went to Tuality Healthcare Foundation; the balance went to United Way \$16,883.

Building a Healthier Community Campaign

In addition to the aforementioned events and Scholarship activity, the major focus of our work this year was wrapping up the Digital Mammography campaign. The original estimate for this campaign was \$1,100,000. This \$1.1MM was to come from the Foundation (\$800,000 in cash and grants), with the remaining balance to come from the hospital in the amount of \$300,000. The original goal was to purchase three machines – two for the Breast Health Center in our 8th Avenue building and one for the Mamm Van, which travels throughout Washington County to work sites including Nike, Intel, Spirit Mountain and others.

Earlier this year, hospital administration decided to take a different approach to this project. For a number of long term, strategic and clinical reasons, the decision was announced that we would open a new Women's Breast Health Center in our 7th Avenue building to house this new equipment. This endeavor includes a fair amount of tenant improvements and renovation to the space including extra costs to retrofit our Mamm Van. At the time of this writing in October, the project is near completion with an estimated opening the second week of November for a total cost of approximately \$2.1MM, \$900,000 of which was raised by the Foundation.
