The Asante Foundation's primary exempt purpose is to raise monies and in-kind donations to further the exempt purpose of Asante, a 501(c)(3) hospital and healthcare system which services the healthcare need of the citizens of southern Oregon and northern California.

Form 990, Part III, Line 4a - Program Service Accomplishments

During the tax year, the Asante Foundation's largest program service accomplishment was the granting of \$1,920,275 to benefit various departments and capital projects at Rogue Valley Medical Center (RVMC), a 378 licensed bed hospital located in Medford, Oregon. Of the capital projects, over \$1,090,000 was donated this year to the Neonatal Intensive Care Unit (NICU) remodel and expansion. This capital project almost doubles the overall size of the NICU and adds an additional 10 bassinets and giraffe beds. All new high efficiency lighting and patient monitoring systems are included in the project. Now completed, the overall increase in patient volume is expected to be modest, but the major focus of the new expansion is to increase the efficiency and quality of care to the babies and their families.

Another major capital project includes the completion of the fundraising campaign to purchase a new \$5 million state-of-the-art radiation tomotherapy machine. Nearly \$132,000 was raised this year to complete the project. The new tomotherapy machine will deliver a precise beam of radiation and can irradiate cancer cells as small as a grain of sand while having minimal or no affect on surrounding tissues. This new machine is expected to save or extend the lives of thousands of cancer patients in the area. In addition to donations for capital projects, the Asante Foundation also helps support numerous clincial departments at RVMC. This includes a generous donation of over \$80,000 to the Hospice department. The Dubs Cancer Center received over \$10,000 of donations and the Francis Cheney Family Place received over \$127,000

during the fiscal year. Other donations help support the Women's Imaging Center, the Emergency Department, Behavioral Health, and the Dialysis Center.

Form 990, Part III, Line 4b - Program Service Accomplishments

The Asante Foundation's second largest program service accomplishment is the granting of \$136,270 to help support various departments and capital projects at Three Rivers Community Hospital (TRCH), a 125 licensed bed hospital located in Grants Pass, Oregon.

During the tax year, the Foundation contributed over \$18,000 toward the purchase of a surgical Vein Viewer, as well as another \$13,000 toward the purchase of a GE Central Monitor system. Also, the Three Rivers Family House received over \$20,000 in general operating donations.

In addition to supporting capital projects, the Foundation also made contributions to various clinical departments of the hospital. This includes the Spears Cancer Center, the Women's Imaging Center at TRCH, and Obstetrics departments, Digital Imaging, and the Emergency Department, to name a few.

Finally, the Foundation was successful in applying for and receiving a generous grant of \$62,000 from the Care Oregon Fund. The Care Oregon Award will help improve patient care processes for glycemic management for diabetes patients and for post-operative nausea and vomiting.

Form 990, Part III, Line 4c - Program Service Accomplishments

The Asante Foundation's third largest program service accomplishment is the granting of several scholarships to various individuals and organizations in southern Oregon and northern California.

During the year, the Foundation gave a \$33,300 scholarship to the Rogue Community College School of Nursing. This scholarship donation will help subsidize the cost of tuition and lab fees for college nursing students. Other scholarships have gone

towards leadership and clinical training programs.

Finally, the Asante Foundation has made donations to the Asante Chaplain Services.

In all, the Asante Foundation granted \$75,931 to the various other programs that help support Asante.

The Asante Foundation's on-going mission is to continually assess the needs of both hospitals it supports, as well as the community we serve. Over the years, the Foundation has contributed millions of dollars to help subsidized important clinical departments of the hospitals and help purchase needed medical equipment. It has also made significant contributions to major building projects at Rogue Valley Medical Center and Three Rivers Community Hospital.

Once all reviews and corrections are made, the CAFO will sign all appropriate returns for filing. The return will then be filed either electronically or paper copy with the appropriate government agencies. A copy of the return is to be kept in Asante's Accounting department and another will be kept at Asante's corporate headquarters for public display and copying, as requested.

Asante's Corporate Compliance Officer is responsible for administering, monitoring, and investigating any possible conflicts and makes an annual report to the Asante Board of Directors.

The data is provided and presented to the Compensation Committee of Asante by an outside consultant. The Compensation Committee sets the actual annual cash compensation for the CEO and salary ranges for the other key employees. The Committee also sets total compensation opportunity for the CEO and each of the key employees, consistent with the executive compensation philosophy. Minutes of the Committee deliberations and decisions are recorded and maintained by Asante. The most recent executive compensation review was completed in 2011.
