The Foundation supports Asian initiatives to improve governance, law, and civil society, women's empowerment, economic reform and development, sustainable development and the environment, and international relations. Drawing on nearly 60 years of experience in Asia, the Foundation collaborates with private and public partners to support leadership and institutional development, exchanges, and policy research. With 19 offices throughout Asia, an office in Washington, DC, and its headquarters in San Francisco, the Foundation addresses these issues on both a country and regional level.

In FY11, Books for Asia distributed over 850,000 books and educational material valued at over \$41 million to schools, universities, public libraries, research institutions, advocacy groups, and government agencies in 18 Asian countries. Working with Asia Foundation field offices and local partners, BFA identifies local needs and priorities, and then distributes donated books where they can have the greatest impact. Every year, BFA receives nearly one million donated books and matches them up to the needs of over 7,500 institutions. More than 97% are new books donated by U.S. publishers.

In helping our Asian partners to strengthen governance reform, our overall goal is to achieve significant impact in helping to address some of the most critical governance challenges in the countries and sub-regions of Asia where the Foundation is among the very few organizations, or the only organization, that could achieve that impact.

The WEP program addresses a range of gender-related issues in virtually all the countries where the Foundation operates. The Program has three strategic and mutually reinforcing programming objectives: to ensure women's rights and security, to increase women's political participation, and to advance women's economic opportunities.
