## 1. THE 200 CLUB STORY:

The story of the 200 Clubs began back in 1950 when Detroit Patrolman Andreas Mellerf was shot in the back as he escorted a charge to a patrol car. He left a young widow, who was shortly due to go to the hospital for her first child. As a widow, she would receive \$4,000 and a pension of \$170 a month.

William Packer, who had helped other policemen's families, decided to write to 100 of his friends urging them to donate to a fund for the policeman's wife. Andreas Mellerf had been killed November 17, 1950. His posthumous child, Kathleen, was born New Year's Eve. By this time his widow, Esther, left the hospital; Packer, Detroit News columnist Jack Carlisle and Police Commissioner George Boos presented her a bankbook with \$7,800. Later, the 200 Club set up a scholarship fund of \$1000 for Kathleen.

Other widows were helped, but Packer began to question why a permanent club wasn't formed with a standing treasury, rather than individual efforts each time a crisis arose. Such a club was incorporated in the summer of 1952 with dues of \$200 a year earmarked solely for widows and dependents. The first membership list of 100 began to grow to 200, 250, and more. Now there are over 500 members.

Other clubs have sprung up across the nation. Some are known by other names: 200 Clubs, Shield Clubs, Bluecoats, Backstoppers and the like; but all share the same common goal of providing benefits to widows and children of slain officers. A number of clubs give awards to officers who exhibit exemplary action in the course of their duties and today the work of the 200 Club continues to expand.

Our Somerset County 200 Club is one out of 19 Clubs in the State of New Jersey and one out of about 92 in the Nation.

## 4. ANNUAL VALOR AWARD LUNCHEON:



During these times our uniformed protectors do not hesitate to protect the public again and again, certain individuals perform heroic acts far above and beyond the call of duty.

At an Annual Awards Luncheon our Somerset County 200 Club will honor those men and women we all respect and admire for their total disregard for their own safety. This is our way to say THANK YOU to these outstanding public servants.

The Valor Award recipients are chosen in part on the recommendations of our public service advisors which include the Somerset County Police and Fire Departments, Rescue Squads and State Police Department.

These Clubs are organizations composed of public-spirited citizens which raise funds through dues, initiation fees, and contributions to provide assistance to surviving members of public safety officers who die in the line of duty. There are often no distinctions drawn between calamities; survivors of a police officer hurt while directing traffic are provided the same benefits as the family of an officer gunned down by a "Saturday night special" wielded by a nationally sought criminal. Such financial assistance has eliminated the unfortunate spectacle of voluntary collections being made following an officer's death that often fall woefully short of meeting fundamental needs.

## GUEST SPEAKER



### Colonel Rick Fuentes Superintendent of the New Jersey State Police

On Monday June 2, 2003, Colonel Joseph R. Fuentes was selected by Governor James McGreevey to become the 14th Superintendent of the New Jersey State Police.

Superintendent Fuentes enlisted in the State Police in January 1978, as a member of the 93A Class. He has served the Division of State Police throughout the state, including assignments as a general road duty Trooper in Central and Southern New Jersey, and an instructor at the Sea Girt Academy. He also was a supervisor with the FBI/NIJSP Joint Terrorism Task Force, Narcotics Units, and the Street Gang Unit. Prior to being named Acting Superintendent, he was assigned as the Chief of the Intelligence Bureau, overseeing nine units within the Intelligence Section.

The recipient of numerous awards, Superintendent Fuentes has been recognized by the U.S. Justice Department, Drug Enforcement Administration, and in 1993 was a co-recipient of the New Jersey State Police Trooper of the Year award.



On January 25th, 2010 at 3:55 am the Branchburg Police received a call from an employee of the Quick Chek located on Route 22. The employee reported that there was an individual inside the store acting in a suspicious manner. The employee described the individual as a black male approximately 6'1" wearing a military style jacket and black cap. Officer Steven Crance was the first officer to arrive on the scene. Upon his arrival, Officer Crance, wisely parked his patrol vehicle at the rear of the building and approached on foot. This procedure allowed him to view what was taking place inside the store and possibly prevent a hostage situation.

Officer Crance observed the individual, later identified as Lloyd Woodson, picking up items and putting them back on the shelf. Officer Crance subsequently entered the Quick Chek and walked past Mr. Woodson. Once inside the store Officer Crance observed a large bulge under Mr. Woodson's jacket which gave the appearance he was armed and possibly wearing a ballistic vest.

At his point, Officer Crance decided to let Mr. Woodson think his presence in the Quick Chek was routine. This quick thinking kept Mr. Woodson from panicking and causing potential harm to the civilians present.

Officer Crance moved toward the coffee area in an effort to keep some type of cover between him and Mr. Woodson. This also would allow Mr. Woodson a free exit path from the store and possibly remove the threat from the civilians. During this time Officer Crance was able to speak briefly with the store manager to ascertain if anyone else was with Mr. Woodson. At this point, Mr. Woodson ran out of the store. Officer Crance was unable to detect Mr. Woodson's direction of travel and did not know if he fled in an awaiting vehicle. Officer Crance radioed Officer Robert Farrigan and Officer Robert Stober, who were responding as back up, that the suspect fled the store and that he appeared armed and wearing a bulletproof vest.

The three officers began to search the immediate area on foot in an effort to locate the suspect. Several minutes later Officer Crance observed Mr. Woodson lying in the hedges near the Regency Trailer Park. He drew his service weapon and ordered Mr. Woodson to show his hands. Mr. Woodson would not comply and after several commands he still did not comply. Against the instructions of Officer's Crance, Farrigan and Stober, Mr. Woodson rose to his feet. He was ordered to the ground and would not comply. Mr. Woodson then ran with the officers in pursuit. Officer Farrigan grabbed his jacket and Mr. Woodson pushed him off. After continuing the foot pursuit for thirty yards Officer Farrigan was able to trip Mr. Woodson causing him to fall to the ground. Mr. Woodson continued to fight the officers. During the struggle they observed a rifle under his jacket in an attempt to control Mr. Woodson, Officer Stober and Officer Crance sprayed him with O.C. pepper spray. This had minimal effect on him and he continued to fight. After several minutes of struggling with Mr. Woodson the officers were able to secure him in handcuffs.

A search of Mr. Woodson's person revealed he was in possession of a 50 caliber Bushmaster military assault rifle, four magazines loaded with hollow point bullets and a military style ballistic vest. Once Mr. Woodson was secured back at the Branchburg Police Headquarters he told the officers that while they were searching for him, he had them in his rifle sight, but did not pull the trigger.

During the questioning of Mr. Woodson it was learned that he was staying in one of the rooms of the Red Mill Inn located in Branchburg. Mr. Woodson gave consent to search his room which uncovered a cache of weapons, including a homemade grenade launcher.

Lloyd Woodson was charged with attempted robbery of the Quick Chek, unlawful possession of an assault firearm, possession of hollow point bullets, possession of high capacity magazines and resisting arrest.


Subsequent to the arrest, information regarding the incident was sent out nationally. It was learned that the Fairfax Virginia Police had an unsolved robbery similar in nature to the attempted robbery of the Branchburg Quick Chek. Surveillance video in the Virginia robbery clearly showed the actor was Lloyd Woodson. With the information and evidence obtained from Branchburg, Fairfax Virginia Police charged Mr. Woodson with armed robbery.



On August 10, 2010 Corporal Michael Price, a 25 year veteran, and Corporal Daniel McNamara, an 18 year veteran, of the Franklin Township Police Department were dispatched to a 9-1-1 call reporting an incident of domestic violence. The caller reported that her father was physically assaulting her mother. Upon arrival, Corporals Price and McNamara encountered the male subject in the rear detached garage of the residence. Corporal McNamara spoke with the male subject while Corporal Price went to house and spoke to the caller and the female party. It was determined that as a result of this incident the male subject was going to be arrested for domestic violence assault. Corporal Price advised the subject he was under arrest. As Corporals Price and McNamara attempted to arrest the subject he struggled and fled. They took chase as the suspect ran to the front of the residence. As the officers attempted to stop the subject, he produced a small caliber handgun and pointed it at the officers. Corporal Price fired a single round that struck the subject. They then immediately rendered first aid until back-up officers and emergency medical personnel arrived.

On the morning of Tuesday, January 19, 2010 while on routine patrol on South Bridge Street at approximately 0934 hours, Officer Obiedzinski's attention was drawn to a green, two door Dodge that was traveling south on South Bridge Street.

The operator of the vehicle sounded his horn several times in quick succession as he passed Officer Obiedzinski. Believing that the driver of the green Dodge was attempting to get his attention and was in need of assistance, Officer Obiedzinski followed the vehicle as vehicle as it turned onto Holly Glen Road.

Upon pulling next to the vehicle on Holly Glen, Officer Obiedzinski encountered the actor who was standing outside his vehicle yelling obscenities at Officer Obiedzinski. Also visible inside the vehicle was a large axe. Realizing that he was not dealing with a citizen in need of assistance, Officer Obiedzinski activated his emergency lights and positioned his patrol car behind the suspect's vehicle. He then exited his patrol car and ordered the actor to return to his vehicle. The actor returned to his vehicle, not to comply with the officer's commands, but to arm himself with a long handled axe and sledge hammer, carrying one in each hand.

As he advanced towards Officer Obiedzinski, Officer Obiedzinski gave him verbal commands to stop and drop the weapons, to which the suspect responded "Do what you gotta do." At this time Officer Obiedzinski drew his weapon and took a position of cover behind his patrol car. The subject, who was now yelling, proceeded to smash out the driver's side rear door window and windshield. After smashing the windshield he advanced on Officer Obiedzinski, who while in fear for his life, discharged his service weapon twice, striking him and ending the threat. Once he was under control, Officer Obiedzinski attempted to call for paramedics to treat his injuries.
