THE NEWARK CAMPUS DEVELOPMENT FUND (NCDF) ACTS AS A CONDUIT FOR GENEROUS DONORS TO ASSIST THE GROWING NEEDS OF THE NEWARK CAMPUS ESTABLISHED IN 1983, NCDF HAS PROVIDED OVER \$4.7 MILLION IN SCHOLARSHIPS AND GRANTS. THE NCDF HAS ALSO FUNDED THE CONSTRUCTION OF THE EVERETT REESE BELL TOWER, THE J. GILBERT REESE TECHNOLOGY CENTER AND THE JOHN AND CHRISTINE WARNER LIBRARY AND STUDENT CENTER AS WELL AS PROVIDING FUNDS FOR TECHNOLOGICAL EQUIPMENT, PARKING, AND CAMPUS BEAUTIFICATION. UNRESTRICTED SCHOLARSHIP AND GRANT FUNDS HELP THE MOST TO MEET THE NEEDS OF STUDENTS.
