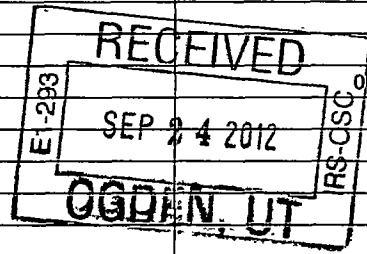

Summary of Direct Charitable Activities

The rainforest land was purchased to achieve the Foundation's mission to preserve the land as a natural habitat for wildlife as well as an area for environmental study. The land is a part of the biological corridor for the wildlife of the Carate-Corcovado region. The staff in Costa Rica has been involved in making major repairs to the facility located on the property but there was delay due to flooding in the remote area just after the purchase. Environmental and educational groups and other visitors will be able to stay, study and become engaged in the ongoing efforts to preserve this biologically intense area of the Osa Peninsula. A website is being developed for the purpose of informing groups of the opportunities at the site as well as at the adjacent Corcovado National Park of Costa Rica. The project will participate with other non-profit organizations and the local community in research and responsible eco-tourist development for living sustainably with the environment.
