15 a. The Chair of the Board of Directors, along with other members of the Executive Committee, conducts an evaluation and job performance of the Executive Director. They report their evaluation to the full board and recommend a level of remuneration.

15 b. The Executive Director conducts an annual job performance review with each employee. The results of the evaluations are shared with the Board of Directors, who then determine the salary levels for the ensuing year.
