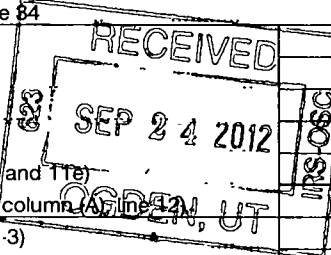

**THE COUNCIL'S GRANTS PROGRAM, AVAILABLE TO ANY TAX-EXEMPT ORGANIZATION IN NEW YORK STATE, IS COMPETITIVE AND ONLINE APPLICATION-BASED. HIGHLY QUALIFIED STAFF AND A PANEL OF OUTSIDE EXPERTS CONDUCT A RIGOROUS REVIEW OF EACH PROPOSAL'S SCHOLARLY MERITS AND VALUE TO THE PUBLIC.
