2. Article 1 of the Corporation's Articles of Incorporation is hereby amended as follows:

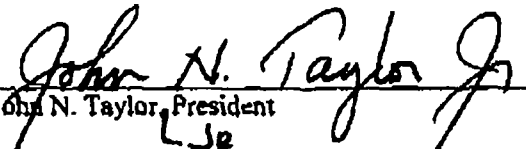
