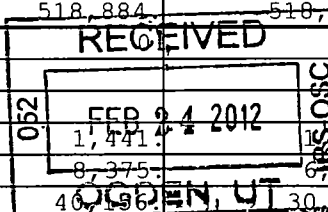

### EXHIBIT 3

#### **AMENDED AND RESTATED TRUST AGREEMENT**

WHEREAS, Andrée LeBoeuf and Jean Gaulin established the ANDRÉE & JEAN GAULIN FOUNDATION (the "Foundation") as a charitable trust pursuant to that certain Agreement dated November 29, 2001 (the "Trust Agreement") in order to support diverse charitable, religious, scientific, literary and/or educational purposes within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 (and corresponding provisions of any subsequent federal tax laws) (the "Code");

WHEREAS, Andrée LeBoeuf and Jean Gaulin were the sole grantors of the Foundation (the "Grantors") and currently serve as the sole trustees of the Foundation (the "Trustees", which shall also refer hereinafter to whomsoever the Trustees may be from time to time);

WHEREAS, after careful consideration the Grantors/Trustees, being all of the persons party to the Trust Agreement, desire to amend and restate the Trust Agreement as hereinafter provided in this Amended and Restated Trust Agreement ("Restatement"), which Restatement shall in all respects supersede the Trust Agreement.

#### **WITNESSETH:**

With the execution of this Restatement, this charitable trust shall be henceforth known as the JEAN GAULIN FOUNDATION (the "Foundation"), and the Foundation's assets shall be held, in trust, with any property added to the trust from time to time (together, the "trust fund"), as follows:

**Article I. Purpose of Trust.** This trust shall be operated exclusively for charitable, religious, scientific, literary and/or educational purposes, including the prevention of cruelty to children or animals, within the meaning of section 501(c)(3) of the Code and the federal income tax regulations thereunder (the "corresponding regulations")(the Foundation's 501(c)(3) exempt purposes"). In carrying out or furthering the Foundation's 501(c)(3) exempt purposes, the Trustees may make payments to or on behalf of, distributions to, and program-related investments in or loans to organizations (i) that are exempt from federal income tax under section 501(a) of the Code as organizations described in section 501(c)(3) of the Code and the corresponding regulations, and (ii) transfers to which are deductible for federal income, gift and estate tax purposes by residents and citizens of the United States of America ("qualified charitable organizations"), and such other payments, distributions, and program-related loans and investments as the Trustees from time to time determine for the Foundation's 501(c)(3) exempt purposes.

No part of the trust fund shall inure to the benefit of or be distributable to the Trustees or any other private individual or entity, except in furtherance of the Foundation's 501(c)(3) exempt purposes. No substantial part of the activities of the Foundation shall consist of the carrying on of propaganda, or otherwise attempting, to influence legislation, and the Foundation shall not participate or intervene in (including the publication or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of this Restatement, the Foundation shall not carry on any activities not permitted to be carried on by a qualified charitable organization.

**Article II. Contributions.** The Trustees may receive contributions from any persons or entities, in cash or other property acceptable to the Trustees, including restricted contributions, provided that (i) the Trustees may not accept inter vivos contributions that are inevitably committed to go to one or more organizations created or organized outside the United States of America or any possession thereof ("foreign charitable organizations"), (ii) the Trustees may, without the order or approval of any court, vary any restriction if the Trustees in their discretion determine that circumstances make literal compliance with that restriction obsolete, inappropriate or impracticable, and (iii) the restrictions must be consistent with the Foundation's 501(c)(3) exempt purposes and its qualifications as a qualified charitable organization and imposed by the donor by written instrument signed and acknowledged by the Trustees and noted upon or kept attached to the executed original of this Restatement held by the Trustees ("valid restrictions"). All contributions received together with the income therefrom shall be held, managed, administered and distributed by the Trustees under the terms of this Restatement. Unless otherwise specifically required, the Trustees may mingle restricted contributions with other assets of the trust fund for investment purposes.

**Article III. Distribution of Trust Fund.** The Trustees shall make payments, distributions and program-related loans and investments from the trust fund, in such amounts, at such times, in such manner and for such of the Foundation's 501(c)(3) exempt purposes as the Trustees in their discretion determine from time to time, subject to any valid restrictions imposed on contributions to the trust fund; provided, however, that any contributions for which a corporation would be entitled, in whole or in part, to the charitable deduction under Section 170 of the Code, and any transfers for which the estate of a decedent nonresident not a citizen of the United States of America would be entitled, in whole or in part, to the charitable deduction under section 2106 of the Code, together with the income therefrom, shall be used solely within the United States of America. Any undistributed income shall be added to principal.

With regard to any payments, distributions or program-related investments in or loans to a foreign charitable organization, the Trustees shall review all requests for funds from each such organization, require that a request specify the use to which the funds will be put, and if the Trustees approve a request as being in furtherance of the Foundation's 501(c)(3) exempt purposes, authorize payment of the funds to the approved grantee on condition that such grantee furnish a periodic accounting to show that the funds were expended for the purposes approved by the Trustees. The Trustees may, in their discretion, refuse to make any such grant or otherwise render financial assistance to or for any or all of the purposes for which funds are requested by a foreign charitable organization; may, in their discretion, withdraw approval of any such grant and instead use such grant funds (including any contributions received in support of such grant) for the Foundation's other 501(c)(3) exempt purposes as determined by the Trustees in their discretion; and shall make the fact that the Trustees' control and discretion over all contributions made to the Foundation in support of a grant to a foreign charitable organization available to any contributor, upon request, whether before or after a contribution has been made.

**Article IV. Termination or Dissolution of Foundation.** This trust shall terminate at the earlier of: (a) the later to occur of date of death of Jean Gaulin or the date of death of Mathieu Gaulin, or if Mathieu is survived by one or more natural or adopted children of the age of twenty-one years or more at the time of his death, then at the death of the last to survive of such children who are willing and capable to serve as Trustee, or (b) the date on which the Trustees determine in their discretion to terminate this trust. Subject to the provisions of the Article entitled "Contributions" regarding restricted contributions to the trust fund, upon termination of the trust, all of the trust fund remaining after payment or adequate provision for the lawful debts and obligations of the Foundation and the expenses of its termination shall be distributed as below.

Similarly, if the Trustees incorporate the Foundation under the power to incorporate granted under this Restatement, the corporation shall be liquidated or dissolved at the earlier of: (a) the later to occur of date of death of Jean Gaulin or the date of death of Mathieu Gaulin, or if Mathieu is survived by one or more natural or adopted children of the age of twenty-one years at the time of his death, then at the death of the last to survive of such children who are willing and capable to serve as Trustee, or (b) the date of which the governing body of the corporation determines, in its discretion to liquidate or dissolve the corporation. Subject to any valid restrictions (as that term is defined in the Article entitled "Contributions") imposed on contributions to the Foundation, upon the winding up and dissolution of the Foundation, all the Foundation's assets remaining after the payment or adequate provision for the lawful debts and obligations of the Foundation and the expenses of its liquidation or dissolution shall be distributed as below.

In either case, the distribution of all of the trust fund remaining after payment or adequate provision for the lawful debts and obligations of the Foundation and the expenses of its termination shall be made to Friends of Polytechnique of Montréal, a District of Columbia corporation (EIN 30-0212646), or if not in existence at the time of distribution, to Fondation de Polytechnique, a Canadian Registered Charity (Charities Registration Number 10183 5502 RR 0001), of Montréal, Quebec, Canada; provided, however, that notwithstanding the foregoing, the Trustees of this trust or the governing body of the corporation, as the case may be, may exercise their sole and absolute discretion to distribute up to twenty-five percent (25%) of the said distribution to one or more qualified charitable organizations (as that term is defined in the Article entitled "Purpose of Trust").

If any one or more of the distributions cannot reasonably be made without the imposition of a tax pursuant to section 507 of the Code, then the trust fund shall be distributed (i) for such of the Foundation's 501(c)(3) exempt purposes (as that term is defined in the Article entitled "Purpose of Trust") and in such manner and proportions as the Trustees shall determine in their discretion, or (ii) to the federal government, or (iii) to a state or local government for a public purpose, or (iv) by a court of competent jurisdiction for the judicial district in which the principal office of the Foundation is then located, exclusively for such of the Foundation's 501(c)(3) exempt purposes or to such one or more qualified charitable organizations (as that term is defined in the Article entitled "Purpose of Trust") having similar 501(c)(3) exempt purposes as the court shall determine.

**Article V. Qualification as Exempt Organization.** It is intended that the Foundation qualify and continue to qualify as a qualified charitable organization. To this end, the Trustees are directed to do whatever is required for the Foundation to so qualify and to refrain from doing anything that would prevent the Foundation from so qualifying. Specifically, in extension and not in limitation of this direction, the Trustees are directed to amend this Restatement under the provisions of the Article entitled "Amendment," to the extent necessary to achieve this objective.

**Article VI. Prohibited Powers.** Notwithstanding any other provisions of this Restatement, the Trustees shall distribute trust income and principal for each taxable year at such time and in such manner so as not to subject the Foundation to the tax on undistributed income imposed by section 4942 of the Code.

Notwithstanding any other provisions of this Agreement, the Trustees shall not engage in any act of self-dealing as defined in section 4941(d) of the Code; nor retain any excess business holdings as defined in section 4943(c) of the Code; nor make any investments in such manner as to subject the Foundation to tax under section 4944 of the Code; nor make any taxable expenditures as defined in section 4945(d) of the Code.

**Article VII. Power to Incorporate.** The Trustees may form and organize a corporation to carry out or further the Foundation's 501(c)(3) exempt purposes. The corporation shall be organized in such state as may be determined by the Trustees. The corporation, if organized, shall succeed to and shall have the sole power to administer and control the affairs and property of the Foundation and to carry out its uses, objects and 501(c)(3) exempt purposes. If the corporation is organized, it shall be named the Jean Gaulin Foundation, or if that name is not available for use, a substantially similar name. Upon the creation and organization of the corporation, the Trustees are authorized and empowered to convey, transfer and deliver to the corporation all the property and assets to which this trust is or may become entitled. It is the purpose of this provision that the corporation, if incorporated and organized as provided by this Article, shall take the place of the Trust Agreement and Restatement as if initially named in the Trust Agreement and Restatement. If the corporation is formed, it shall have the same powers and authority as are vested in the Trustees by this Restatement, subject to the same limitations and restrictions; provided however that the corporation may have such additional powers as permitted by statute as are not inconsistent with this Restatement. The Trustees shall be the incorporators of the corporation, together with such other persons as may be chosen for the purpose, and the Trustees shall constitute and act as the first board of directors of the corporation, together with such other persons as the Trustees may select. The articles of incorporation, certificate of incorporation, bylaws, and other provisions for the organization and management of the corporation, its affairs and property shall be such as the Trustees shall determine consistent with the provisions of this Article; provided, however, that the corporation shall be organized and operated so as to qualify as a qualified charitable organization.

**Article VIII. Amendment.** The trust fund shall remain irrevocably dedicated to charitable purposes as otherwise specifically provided in this Restatement. The Trustees shall have the power, without consent of any interested party, to amend or modify this Restatement at any time either as required by the Article entitled "Qualification as Exempt Organization" or in any other manner or for any other purpose consistent with the Foundation's 501(c)(3) exempt purposes, its qualification as qualified charitable organization and the valid restrictions imposed on contributions to the trust fund; provided, however, that no amendment or modification may be made that would cause the Foundation to violate any provision of the Code or corresponding regulations applicable to private foundations within the meaning of section 509 of the Code, and no amendment or modification to any power of amendment hereunder may remove these restrictions from such power, and provided further, that only the person or persons who hold the power to remove Trustees, as set forth in the provisions of the Article entitled "Appointment of Trustees" shall have the power to amend those trustee removal provisions. Every amendment to or modification of this Restatement shall be by written instrument signed and acknowledged by the Trustees and, in the case of amendments to the Trustee removal powers, by the person or persons having the power to amend those provisions, and shall be noted upon or kept attached to the executed original of this Restatement held by the Trustees.

**Article IX. Definition of Trustee.** Except as otherwise provided herein, any Trustee who acts under this Restatement may exercise all of the rights, powers and discretions and shall be entitled to all of the privileges and immunities granted to the named Trustee. Any references in this Restatement to the Trustees shall include (unless otherwise expressly provided) all Trustees from time to time. No surety bond shall be required of any Trustee.

**Article X. Appointment of Trustees.** From the effective date of this Restatement, the Trustees hereunder shall be Jean Gaulin and Mathieu Gaulin, and Andrée LeBoeuf shall cease to be a Trustee of the Foundation and forfeit any and all right, title, and interest in the Foundation or the trust estate under the Trust Agreement and Restatement. Jean Gaulin acting alone may remove any Trustee or appoint one or more Trustees at any time. If either Jean Gaulin or Mathieu Gaulin shall cease to act due to incapacity or death, the other Trustee may appoint such of Mathieu Gaulin's adult children, if any, who are able and willing to act as Trustee. The Trustees acting together may appoint one or more additional Trustees or successor Trustees at any time. Any individual Trustee may at any time appoint his or her successor as Trustee, individual or corporate, subject to approval of any other Trustee(s) at the time. If Jean Gaulin and Mathieu Gaulin die without having appointed other Trustees, or if a child of Mathieu Gaulin has served as Trustee and dies without having appointed a successor, or there are otherwise no Trustees then serving, then Friends of Polytechnique of Montréal shall become a corporate successor Trustee for the purpose of an orderly winding up and termination of the Foundation's affairs and final distribution. If Friends of Polytechnique of Montréal is not in existence, then Fondation de Polytechnique shall become a corporate successor Trustee for the purpose of an orderly winding up and termination of the Foundation's affairs and final distribution, and if by the law of its domicile or other policy it is not permitted to serve in a trustee capacity, it shall appoint a U.S. person or entity as Trustee for this purpose. Such appointments shall not require court approval.

Any Trustee is authorized to resign at any time without court approval. The resignation, appointment, revocation of appointment, or removal of a Trustee may be made by the persons authorized to take such action by delivery of an acknowledged instrument to the Trustees then acting and any Trustee to be appointed, or, if none, to a court having jurisdiction over the trust. Any appointment of a Trustee may be conditioned to commence or cease upon a future event and may be revoked or modified at any time before that future event has occurred. Unless otherwise expressly provided, any power to appoint a Trustee shall permit appointment of an individual or institution qualified to act as such Trustee such as a corporate trustee, and any power to appoint (but not to remove) a Trustee shall be exercised by the parent (or, if none, the legal representative) of any minor and the legal representative of any incapacitated person holding such power.

A determination that any individual Trustee is incapacitated shall be deemed a resignation by that individual as Trustee as of the date of the determination. An individual Trustee shall be considered incapacitated if the individual is under a legal disability or by reason of illness or mental or physical disability is unable to give prompt and intelligent consideration to financial matters. The determination as to whether an individual Trustee is incapacitated shall be made by our Trustees other than the individual, or, if none, by the institution or individual designated to succeed the individual as Trustee, who may rely conclusively upon (1) the written opinion of the individual's primary physician, (2) the written opinion of any two independent physicians who have in good faith examined the individual for the purpose of determining whether the individual is incapacitated, or (3) the written order of a court appointing a conservator or guardian of the individual's person or property.

**Article XI. Investment Counsel.** Subject to the provisions of the Article entitled "Prohibited Powers", the Trustees may employ investment counsel; consult with such counsel on any matters relating to the retention, sale, purchase, investment, or reinvestment of securities or other property; delegate to such investment counsel the Trustees' investment authority; and pay such investment counsel reasonable compensation for services in addition to paying regular compensation to any non-individual Trustees. The Trustees may act upon or refrain from acting upon the advice of such investment counsel in whole or in part, and to the extent the Trustees follow the advice of such investment counsel or reasonably rely upon such investment counsel's exercise of delegated investment authority, our Trustees shall not be liable for any action taken or omitted, except in the case of willful misconduct.

**Article XII. Governing Law.** From the effective date of this Restatement, the validity, construction, and administration of this Restatement and trust shall be governed by the law of Texas. However, in any conflict with section 501(c)(3) of the Code, the corresponding regulations or any other requirements for the qualification of the Foundation as a charitable organization, section 501(c)(3) of the Code, the corresponding regulations and any such other requirements shall govern this Restatement and trust.

**Article XIII. Delegation.** Except as otherwise expressly provided herein, any Trustee may delegate to the other Trustees the right to exercise any power (discretionary, administrative or otherwise) and may revoke the delegation at any time by delivery of an acknowledged instrument to such other Trustees, including the payment of any taxes, interest, penalties and quarterly estimated taxes the Foundation may owe, and request extensions of time to file any such returns or forms or to pay such taxes, and to take any and all further actions as in the judgment of the Trustee so acting, may be necessary or advisable in connection with the foregoing. Provided however that while Trustees may delegate the preparation of the annual Return of Private Foundation, IRS Form 990-PF, contemporaneous with the filing, each Trustee shall review the annual Return of Private Foundation, IRS Form 990-PF as well as any corresponding state returns or forms the Foundation may be required to file from time to time.

**Article XIV. Majority Controls.** Except as otherwise expressly provided herein, in the event of a disagreement among the Trustees, the decision of the majority shall control and shall be as effective as if the decision had been made unanimously; provided, however, that in the event of a deadlock vote of Trustees, Jean Gaulin in his sole and absolute discretion shall have the deciding vote to break the deadlock. A Trustee not joining in a decision of the majority or resolved as aforesaid shall not be liable for any action taken pursuant to it.

**Article XV. Trustee Duty and Liability.** Each Trustee shall discharge fiduciary duty to the Foundation in good faith, with the care an ordinarily prudent person in a like position would exercise under similar circumstances, and in a manner such Trustee reasonably believes to be in the best interests of the Foundation. Each Trustee, in discharging fiduciary duty to the Foundation shall be entitled to rely on information, opinions, reports or statements, including financial and other financial data, if prepared or presented either (i) by an employee or agent of the Foundation whom such Trustee reasonably believes to be reliable and competent in the matters presented, or (ii) by an attorney, public accountant or other person retained by the Trustees as to matters such Trustee reasonably believes are within such person's professional competence; provided, however, that a Trustee shall not be considered to be acting in good faith if such Trustee has knowledge concerning the matter in question that makes such reliance unwarranted. A Trustee shall not be liable or accountable for any mistake or error of judgment, for any action taken or omitted by any other Trustee, or for any loss or depreciation in the value of the trust fund, unless it (a) involved a knowing and culpable violation of law by such Trustee, (b) enabled such Trustee to receive an improper personal economic gain, (c) showed a lack of good faith and a conscious disregard for Trustee's fiduciary duty under circumstances in which such Trustee was aware that the conduct or omission created an unjustifiable risk of serious injury to the Foundation, or (d) constituted a sustained and unexcused pattern of inattention that amounted to an abdication of such Trustee's fiduciary duty to the Foundation.

**Article XVI. Indemnification.** Subject to the Article entitled "Prohibited Powers", the Foundation may indemnify any person, or the legal representatives thereof, made a party to any proceeding by reason of the fact that such person is or was a Trustee, employee or agent of the Foundation, or that such person is or was serving at the request of the Foundation as a director, officer, partner, trustee, employee or agent of another enterprise, to the full extent permitted by Texas state law, including, by analogy, any Texas state corporate law governing the indemnification of directors and/or officers of nonprofit corporations, and, prior to the final disposition of any such proceeding, may pay or reimburse the reasonable expenses incurred by such person in connection therewith to the fullest extent permitted by such state laws if (i) such person furnishes the Foundation a written

affirmation of good faith belief that he or she has met the standard of conduct described in the Article entitled "Trustee Duty and Liability", (ii) such person furnishes the Foundation a written undertaking, executed personally on his or her behalf, to repay the advance if it is ultimately determined that he or she did not meet that standard of conduct, and (iii) a determination is made that the facts then known to those making the determination would not preclude indemnification under this Article. The intent of this Article is and it shall be interpreted to authorize the Foundation to provide the fullest possible indemnification of, and advance of expenses to, each person who is or was a Trustee, employee or agent of the Foundation and each person who is or was serving at the request of the Foundation as a director, officer, partner, trustee, employee or agent of another enterprise, that is permitted by state law and not prohibited by the federal laws applicable to qualified charitable organizations.

**Article XVII. Powers.** Subject to the Article entitled "Prohibited Powers", and to the condition that no power or discretion shall be exercised by the Trustees in any manner or for any purpose that is not consistent with the Foundation's 501(c)(3) exempt purposes, its qualification as a qualified charitable organization, and the valid restrictions imposed on contributions to the trust fund, but without otherwise limiting the powers conferred upon them by law, the Trustees are authorized and empowered, without the order or approval of any court: (1) To retain, acquire, or sell any variety of real or personal property (including any discretionary common trust fund of any corporate Trustee acting under this document, mutual funds, covered or uncovered stock options, and investments in foreign securities), without regard to diversification and without being limited to the investments authorized for trust funds; (2) to exercise stock options; (3) to enter into agreements for the sale, merger, reorganization, dissolution or consolidation of any corporation or properties; (4) to manage, improve, repair, sell, mortgage, lease, pledge, convey, option or exchange any property and take back purchase money mortgages thereon; (5) to form or join in forming partnerships, limited liability companies or corporations to carry out or further the Foundation's 501(c)(3) exempt purposes or for investment purposes, to transfer any part or all of the trust fund thereto, and to operate, manage and supervise such entities, participate in the operation, management and supervision thereof, or delegate such power to any person or persons the Trustee's may select; (6) to make any distribution in cash or in kind, or partly in each; (7) to maintain custody or brokerage accounts and to register securities in the name of a nominee; (8) to compromise and settle claims (including those relating to taxes); (9) to borrow funds from any person or corporation and pledge or mortgage trust assets to secure such loans; (10) to extend, renew or renegotiate loans or guarantees; (11) to initiate and participate in fundraising activities, expeditions or other projects to further or promote the Foundation's 501(c)(3) exempt purposes; (12) to employ attorneys, accountants, investment counsel, custodians, brokers and other agents to assist in the administration of the trust fund and to pay reasonable compensation for such services; (13) to vote and give proxies to vote shares of stock; and (14) to open, close, maintain, draw checks on (and in any other manner withdraw funds from) and make deposits to bank accounts of any kind.


