EGGNOG LATTE FOUNDATION REIMBURSES BOARD MEMBERS FOR THE EXPENSES INCURRED IN CONDUCTING FOUNDATION BUSINESS. THESE EXPENSES ARE PROPERLY SUBSTANTIATED AND ARE CONSIDERED REASONABLE. THEREFORE, THE REIMBURSEMENT IS NOT CONSIDERED AN ACT OF SELF-DEALING UNDER IRC SECTION 4941(D)(2)(E).

ADDITIONALLY, DURING THE PRIOR TAX YEAR, THE FOUNDATION PAID THE EXPENSES OF TWO DISQUALIFIED PERSONS. THE AMOUNTS HAVE NOT BEEN TREATED AS A QUALIFYING DISTRIBUTION AND HAVE BEEN TREATED AS AN EXPENSE ADVANCE. CORRECTION WILL BE MADE IN THE FISCAL YEAR ENDING NOVEMBER 30, 2012.
