The Deputy Director may act in similar capacity as the Executive Director in his/her absence. The Board sets the compensation and benefits of the Executive Director. SEK-CAP performs a wage comparability study annually to ensure the salary and wage structure is similar to other organizations of like size and employee base in our area.

SEK-CAP adheres to the executive level salary cap that prohibits the use of federal funds to pay any portion of compensation to an above Executive Level II, which is \$179,700 for 2011/2012. Compensation is defined to include salary, bonus, leave, and benefits.

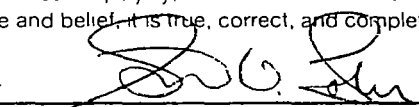
