ARTICLES OF MERGER

Valley Imaging
and
Yakima Valley Memorial Hospital Association

Pursuant to RCW 24.03.200, Valley Imaging, a Washington nonprofit corporation, and Yakima Valley Memorial Hospital, a Washington nonprofit corporation, do hereby execute and submit these Articles of Merger for filing.

1. Plan of Merger. Pursuant to RCW 24.03.185, Valley Imaging and Yakima Valley Memorial Hospital Association have adopted a Plan of Merger, which is attached hereto as Exhibit A. Yakima Valley Memorial Hospital Association is the surviving entity. The merger shall be effective as of November 1, 2011.

2. Approval by Member of Valley Imaging. The Plan of Merger was duly adopted by Yakima Valley Memorial Hospital Association, the sole Member of Valley Imaging as provided in RCW 24.03.200. The Member adopted the Plan by a consent in the form of record executed by the sole Member entitled to vote with respect to the Plan.

3. Approval by Yakima Valley Memorial Hospital Association. Yakima Valley Memorial Hospital Association has no members. The Board of Trustees of Yakima Valley Memorial Hospital Association, at meeting held on October 31, 2011 at which a quorum was present, approved and adopted the Plan of Merger by the vote of a majority of the Trustees in office.

PLAN OF MERGER

**Valley Imaging
and
Yakima Valley Memorial Hospital Association**

THIS PLAN OF MERGER ("Plan") is made and entered into by and between Valley Imaging, a Washington nonprofit corporation ("Valley Imaging") and Yakima Valley Memorial Hospital Association, a Washington nonprofit corporation ("Memorial").

RECITALS

- A. Valley Imaging is a nonprofit corporation organized and existing under the laws of the State of Washington. Memorial is the sole member of Valley Imaging;
- B. Memorial is a nonprofit corporation organized and existing under the laws of the State of Washington;
- C. Valley Imaging and Memorial desire to effect the merger of Valley Imaging with and into Memorial (the "Merger") so that Memorial is the surviving entity.

PLAN OF MERGER

In consideration of the mutual promises and covenants set forth below, the parties hereto, intending to be legally bound, mutually agree to this Plan of Merger upon the following terms and conditions:

- 1. Merger. Upon the terms and conditions of this Plan, and in accordance with RCW 24.03, Valley Imaging shall be merged with and into Memorial and the separate legal existence of Valley Imaging shall cease. Memorial shall be the surviving entity of the Merger and shall continue its corporate existence under the law of the State of Washington.
- 2. Effective Date of Merger. The Merger shall be effective November 1, 2011 (the "Effective Date").
- 3. Effect of the Merger. As of the Effective Date:
 - a. Valley Imaging shall be merged with and into Memorial, and Memorial shall be the surviving entity;
 - b. The separate existence of Valley Imaging shall cease;
 - c. Memorial shall possess all the rights, privileges, and immunities of Valley Imaging, to the extent the same are not inconsistent with the nature and charitable purpose of Memorial, and all property, real, personal, and mixed, all trade names and trademarks and associated goodwill, and all debts due on whatever account, and all and every other interest of or belonging to or due to Valley Imaging, shall be taken and deemed transferred to and vested in

Memorial without further act or deed; and title to any real estate, or any interest therein, vested in the merging entities shall not revert or be in any way impaired by reason of the merger;

d. Memorial shall thereafter be responsible and liable for all the liabilities and obligations of Company, and any claim existing, or action or proceeding pending, by or against either of the merging entities may be prosecuted as if the Merger had not taken place and Memorial may be substituted in the place of Valley Imaging; and

e. All contracts and agreements of Valley Imaging shall be deemed transferred to, vested in, and binding upon Memorial, and all accreditations, certifications, and licenses are transferred to Memorial consistent with such notices and procedures required by applicable outside entities.

4. Articles of Incorporation. The Articles of Incorporation of Memorial in effect on the Effective Date shall be and remain the Articles of Incorporation of Memorial until the same shall be amended or repealed as authorized by the Board of Trustees of Memorial.

5. Bylaws. The Bylaws of Memorial in effect on the Effective Date, shall govern Memorial until the same shall be amended or repealed as therein provided.

6. Conversion of Membership Interest. The membership interest in Valley Imaging held by Memorial shall convert and merge into the ownership interest of Memorial as of the Effective Date.

7. Entire Agreement. This Plan constitutes the entire agreement between the parties. There are no oral or other agreements, except as herein expressed. This Plan may be amended only by a writing signed by both parties hereto.
