THE CONFERENCE WAS THE 98TH INTERNATIONAL EDUCATIONAL CONFERENCE PROVIDED AS AN EXCEPTIONAL PROGRAM FOR THOSE IN THE WORKFORCE DEVELOPMENT PROFESSION, AND THE PROGRAM CONTENT INCLUDED TOPICS SUCH AS POVERTY, EFFECTS OF GLOBAL RECESSION, VETERAN'S VOCATIONAL REHABILITATION, AND BENEFIT PAYMENT CONTROL BEST PRACTICES. THE CONFERENCE PROVIDED 16 HOURS OF EDUCATIONAL OPPORTUNITIES DIVIDED INTO GENERAL SESSIONS AND WORKSHOPS IN THE FOLLOWING FOUR TRACKS: WORKFORCE SERVICES, UNEMPLOYMENT SERVICES, VETERANS PROGRAMS, AND PROFESSIONAL GROWTH. THE CONTINUING EDUCATION SECTION OF THE UNIVERSITY OF MISSOURI PROVIDED CONTINUING EDUCATION UNITS (CEUs) FOR THE CONFERENCE.
