Our mission is to provide financial support for, and advice to, Gethsemane Garden Christian Centre, a Christian boarding school in Western Kenya, which provides housing, clothing, food, and a quality education to almost 500 students (over 80% are orphans) from the Suba Tribe. The school is located on Mfangano Island in Lake Victoria.

During fiscal year 2011, the organization made grants of \$511,578 to Gethsemane Garden Christian Centre in Western Kenya. These grants were made possible through charitable donations from a donor base of over 400. The Christian boarding school has almost 500 students from Kindergarten through Grade 11. Grade 12 will be added in 2012 with the first class graduating in 2013. Grants in 2011 were made for both monthly operational expenses and capital expenses associated with the Lower and Upper Schools. A detailed listing of the grants and the uses can be found in Schedule F attached to this return. Our organization makes on-site visits on at least an annual basis (normally more often) and requires the Kenyan school to undergo an annual audit by a reputable CPA firm out of Nairobi, Kenya. Of particular note, during 2011, the Upper School (grades 9 - 12) classroom building was substantially completed with \$143,348 of the grants going for construction of that building. The remaining grant funds were for budgeted monthly operating expenses of \$28,600 and one-time items which arose during the course of the year. The \$1,561 difference in expenses and grants were direct expenditures for the Community Health Evangelism outreach program conducted through the school. No revenue is shown since the program service itself did not generate revenue but was supported by contributions.

Part VIII, Statement of Revenue: The organization does hold an annual banquet at which its donors are updated on the activities of the current year and are apprised of future plans. There is no charge for attendance at the dinner where attendees are our guests and, while donations are accepted, they are not required. Even though some donations are \$75 00, or more, the donor receives a tax exemption receipt for the full amount of the gift since there is only an indirect relationship between the meal and the gift and there is no quid pro quo.

The organization also held a walk-a-thon during the year where only contributions were generated. Accordingly, both the dinner and walk-a-thon contributions are included in line 1f. Expenses of the dinner are included in Section IX, Line 24a. A silent auction was also held during 2011 and the items donated are accounted for in line 1f and g as non-cash contributions; however, since none of the items sold for more than the FMV, no contributions were generated as a result of the auction and the event actually lost money. A small raffle was held at the same time which was revenue neutral.
