Technical Support for Mentoring Programs Mobius provides ongoing training for new mentors, training on special topics for experienced mentors, and training and consultation for mentoring program coordinators. In addition, Mobius assists new mentoring programs to establish procedures and policies consistent with accepted best practices. Other programs: In addition to the program areas described above, Mobius organizes events for mentors and mentees which raise morale of mentors and encourages longer-lasting matches. When opportunities are available, it raises funding for mentoring programs to support their personnel and other costs. Mobius undertakes activities that help mentoring programs prosper and grow so they can serve more children.

Public Awareness Mobius promotes public awareness of mentoring and local mentoring programs with press releases, paid media, appearances on local interview programs, and through other means. By raising public awareness of mentoring, Mobius promotes both volunteerism and philanthropy that helps mentoring programs grow.

Volunteer Recruiting Mobius recruits, screens, and trains volunteers and refers them to local mentoring programs.
