Orange County Cornerstone Outreach was formed to help provide a safety-net of services for individuals in need. The purpose is to provide help for those who do not qualify for other government services, and/or those who have needs that are not being met by other agencies or programs. We provide emergency assistance for individuals and their families. We develop needs-based programs to help meet the physical, emotional, and spiritual needs of our community.

Current programs include: HIV/AIDS, "Adopt-A-Family," and our weekly food and toiletries distribution. We provide food, clothing, toiletries, toys, and other necessities to local families in need. Cornerstone Outreach is also developing programs for LGBT youth and LGBT seniors.

We work with other agencies, individuals, and corporations in our community to assess needs and then solicit donations and volunteers to help meet those needs. For example, we provide a local AIDS service organization toiletry kits for them to distribute to their homeless clients and backpacks for their children who are infected and affected by HIV/AIDS.
