THE NURSES WORK WITH LOCAL CANCER CARE PROVIDERS TO PROVIDE A SINGLE, CONSISTENT POINT OF CONTACT FOR CLINICAL QUESTIONS AND CONCERNS. NURSE NAVIGATORS EFFECTIVELY ADVOCATE ON BEHALF OF PATIENTS AND THEIR LOVED ONES WHO OFTEN FIND THEMSELVES ADRIPT IN UNCHARTED WATERS.
