LITIGATION OTHER ADVOCACY Represents clients individuals below 200 of the federal poverty level before administrative agencies, the state legislature, and state and federal courts primarily with regard to systemic issues related to food assistance, health care, income support programs, and housing and utility-related matters MEJP handled over 430 cases in 2011, including administrative and legislative matters as well as direct client services These included 165 cases regarding health care primarily Medicaid related, 163 cases concerning food assistance and income support programs, 27 cases regarding housing and utility matters, and 17 cases dealing with consumer issues, and 24 cases concerning employment matters MEJP also conducted more than 45 separate training and education events throughout the state on issues and public benefit programs affecting people with low income, reaching close to 1,400 service providers and advocates A class action lawsuit filed in federal court by MEJP and other legal partners on behalf of young adults with physical disabilities confined to nursing homes was settled in 2011 The settlement calls for the state to develop a program for these individuals that provides community-based treatment options and enhances their ability to live independently
