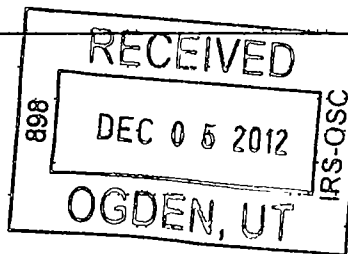

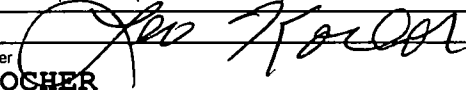
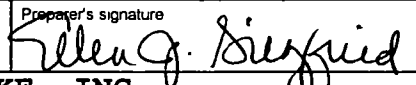

2. The following amendment of the Articles of Incorporation was adopted by the Corporation in the manner prescribed by the District of Columbia Non-profit Corporation Act:

College Sports Council (the "Corporation"), a nonprofit corporation organized and existing under and by virtue of the District of Columbia Nonprofit Corporation Act, D.C. Code Sections 29-301.01 et seq. (the "Act"), does hereby certify:

FIRST: The name of the Corporation is College Sports Council

SECOND: That the Articles of Incorporation shall be amended by deleting ARTICLE FIRST in its entirety and substituting the following in lieu thereof:

"FIRST: The name of the Corporation is AMERICAN SPORTS COUNCIL (hereinafter referred to as the "Council")."

THIRD: That the Articles of Incorporation shall be further amended by inserting the phrase "scholastic, club, intramural and" before the word "collegiate" in clause (a) of paragraph (2) of ARTICLE THIRD.
