In 2011, Global Resource Alliance assisted in the completion of 7 new boreholes in the Mara region of Tanzania fitted with top quality Dutch made hand pumps. We also provided in field training in site location, report writing and funded community mobilization efforts and equipment repair. The largest expense of the water project is equipment depreciation followed by interest on loans for the purchases of hand pumps by container lots.

4b (Code:) (Expenses \$ 74,443 including grants of \$ 56,316) (Revenue \$ 0)

Global Resource Alliance provides funding for a permaculture project in Kinesi Village that employs and trains 16 local villagers who grow food for families in the village caring for orphans. There are a total of 12 acres under cultivation at present. We also fund a tree planting project that trains local residents to plant and care for trees and have distributed over 130,000 free trees.

4c (Code:) (Expenses \$ 32,183 including grants of \$ 30,781) (Revenue \$ 0)

Global Resource Alliance provides funding for several different orphan support programs. One project supports about 80 orphans in Musoma Town who receive food supplements for their foster families, soap, school supplies, school fees, health care and counseling. Another project in Kinesi Village supports all of the orphans in the village needing help with similar support. A third project provides pre-school education, activities and one hot meal a day.
