DESCRIPTION OF ORGANIZATION

The Circle Cinema Foundation, Inc., Tulsa's non-profit film arts organization, was established in 2003 as a 501(c)(3) organization by community-minded individuals who recognized the importance of saving Tulsa's only remaining historic movie theatre for historical, educational and cultural purposes. With the goal of restoring the Circle to its prominence as a movie theatre and to create a unique cultural venue for community members of all ages, the Foundation also established a commitment to focus on film programming that would be multi-purpose and *mission-based – to educate, to enlighten and to entertain – by using film to foster understanding and appreciation of the diversity of the human experience and to create community among its viewers.*

In 2003, the Foundation purchased the vacant Circle Theatre building at 10 South Lewis and the adjacent building at 12 South Lewis in Tulsa's historic Kendall-Whittier district in order to restore the original theatre and to add additional screens. A Community Development Block Grant through the City of Tulsa facilitated acquisition. The Circle Theatre holds the great distinction of being added to the National Register of Historic Places in 2003.

The 12 South Lewis property was developed first in Phase I of the Foundation's master plan through the generous support of community donors. In this space, an auditorium with 105-seat capacity, a lobby, a concession and ticketing counter, wall area for art exhibits, and a small screening room which seats up to 50.

Since opening in October 2004, Circle Cinema has become a vital component of the Tulsa community not only with sold-out screenings and special events occurring on a regular basis, but also with the unique community partnerships established with over 35 lower and higher education schools, over 60 other local non-profit organizations and more than 20 local clubs. In short, Circle Cinema represents a true community treasure – a place for citizens of all ages to be engaged 365 days per year.

Unlike a typical movie complex, Circle Cinema focuses on independent films, documentaries, foreign films, and classics – films that Tulsans rarely have an opportunity to view locally. To enhance the film arts experience, the Circle routinely hosts film festivals; film events with guest speakers (i.e., directors, writers, actors, producers, musicians, artists, historians, eyewitnesses, educators) and Q & A sessions; film premieres of locally-made films; films created by local filmmaking students; films co-sponsored with other local non-profit organizations; and free film and art events open to the public. Additionally, Tulsa area students/educators in public and private schools from K – College participate in educational film programs that are age-appropriate and multi-disciplinary.

On July 15, 2008, the Circle celebrated its 80th birthday amidst public fanfare and the Foundation used this opportunity to officially announce the *Full Circle Capital Campaign* to raise the funds needed to begin the final phase – Phase II – to add two additional larger auditoriums in what was the original Circle Theatre building and to restore the original lobby space and the front theatre entrance with a building façade in a vintage style reminiscent of its look in the 1950s.

Since opening, the Circle has already developed strong relationships with over 35 lower and higher education public and private schools and looks forward to fulfilling the needs of larger school groups once the Circle is completed with an additional 388 seats available.

School offerings, to date, include:

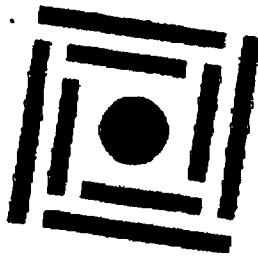
- *Journeys in Films* national program for Tulsa area middle school students and educators

- Films presented in association with curriculum - i.e. history, social studies, language and geography
- Guest speakers with Q & A sessions following school screenings
- Free use of facility for student groups and club meetings
- Filmmaking workshops for Tulsa area high school students
- Films created by filmmaking classes and young filmmakers
- Complimentary bus transportation when needed; complimentary movie passes to school organizations

COMMUNITY PARTNERSHIPS

In less than 4 years of operation, the Circle has developed partnerships with over 62 other non-profit groups and 22 clubs and organizations in a variety of ways including:

- Co-sponsoring compelling films with other non-profit organizations for their audiences, as well as providing guest speakers for their events on diverse subjects including, but not limited to, religion, social issues, discrimination, health, environment, art and politics
- Hosting the Oklahoma Movie Makers who meet every Thursday and utilize the Quad screening area
- Popular rental facility for local clubs, organizations, businesses and individuals to hold meetings, workshops and special events

SCHOOL PROGRAMMING & PARTNERSHIPS

Circle Cinema is dedicated to creating community consciousness through film. The Foundation's Mission is to *use film to foster understanding and appreciation of the diversity of the human experience, and to create community among the viewers in the restored historic Circle Cinema*. The Foundation believes in the importance of film as a teaching tool and appreciates all opportunities to work with public and private schools and educators to provide a learning experience for students and educators through film.

Circle Cinema is a long-time participant in the *Partners in Education* program offered by the Metro Tulsa Chamber of Commerce by partnering with Kendall-Whittier Elementary School located in its neighborhood. An educational film program was created to provide a film and theatre experience to each child in first through fifth grades at Kendall-Whittier. Classes are invited to attend an age-appropriate film, learn about how films are made and about theatre etiquette, in addition to a discussion about the topic of the film.

The Foundation provides film programming for public and private school students of all ages on such topics as historical events, societal issues, language studies, culture, diversity, and environmental and health concerns. Educational film programming is provided at no cost to the schools.

Circle Cinema has been a sponsor of the national program, *Journeys in Film*, which provides an interdisciplinary approach to global education for middle-school age children.

Circle Cinema partners with the Kendall Whittier Library to offer a free kids summer film series that is tied to the library's summer reading program. In addition, *KIDS First Film Festival* programs are offered on occasion screening popular films free of charge to families.

Circle Cinema is a partner in Tulsa Public School's *Teaching American History* program which presents a semi-annual academic colloquium for history teachers encompassing a film and lecture tied to an American history topic.

Public and private school film studies programs are provided opportunities to screen student films and hold film festivals at Circle Cinema.

Film can be a powerful tool and because there are films about so many different topics and subjects, the opportunities are virtually endless for Circle Cinema to work with schools and educators to help educate and increase public awareness through film.
