 Educational Program - The Organization's educational program achievements included teleconferences and webinars on topics of interest to progressive women donors such as socially responsible investing, growing clean energy economies, domestic workers' issues, promoting peace in the Middle East, building cross-alliance movements, advocating for the rights of imprisoned mothers, safe-guarding the right to vote, and state-led strategies on immigration reform. Topics addressed through in-person seminars included "Critical Connections: Developing a Shared Framework for Race and Gender," "Leading from the Inside Out: Strengthening our Capacity to be Better Advocates," "Passing on Your Values Along with Your Wealth," and a two-day advocacy training on "Learning to be Effective Public Women," held in Washington, DC. Finally, the Organization held its Annual Conference for women donors. The 2011 conference, which took place in Denver, CO, was organized around the theme "Challenging Corporate Power & Forging a Progressive Agenda," and the 100 participants gathered to learn to be more effective philanthropists, to build community, and to strategize for the future.

 Action Initiatives - The Organization supported several initiatives in pursuit of its progressive vision of a more fair and just world during 2011. These action initiatives included support for the "Moving Forward" initiative to advance women's reproductive health and rights in alliance with the Communications Consortium Media Center. Grants were also provided to support environmental advocacy against the transport of massive oil-industry equipment through several Western states, an initiative to support women in Haiti, and funding for an environmental organization working with indigenous communities in Montana and elsewhere. Additional funded projects included completion of a case study of the "Moving Forward" initiative and a continuing fellowship to support research and writing on Native American activist Elouise Cobell and the federal litigation she has led in support of indigenous communities' land rights.
