We have audited the balance sheet (Part X) of International Brotherhood of Teamsters Local Union 191 as of December 31, 2011, and the related statement of revenues, expenses and changes in net assets (Part I) and the statement of functional expenses (Part IX) for the year then ended included in the accompanying Internal Revenue Service Form 990. These financial statements are the responsibility of the Union's Executive Board. Our responsibility is to express an opinion on these financial statements based on our audit.

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Those standards require that we plan and perform the audit to obtain reasonable assurance about whether the financial statements are free of material misstatement. An audit includes examining, on a test basis, evidence supporting the amounts and disclosures in the financial statements. An audit also includes assessing the accounting principles used and significant estimates made by management, as well as evaluating the overall financial statement presentation. We believe that our audit provides a reasonable basis for our opinion.

The financial statements have been prepared under a modified cash basis, whereas, certain revenue and the related assets are recognized when received rather than when earned, and certain expenses are recognized when paid rather than when the obligation is incurred except for property, plant and equipment which are capitalized and depreciated over the estimated useful lives of the assets and the recording of a note payable and a payroll tax payable. Although these procedures comply with Internal Revenue Service instructions, the format and disclosures differ in certain respects from generally accepted accounting principles. Accordingly, the accompanying financial statements are not intended to present financial position and results of operations in conformity with generally accepted accounting principles.
