It has 3 core programs which are Research, Research Capacity Strengthening and Policy Engagement & Communication

The research is organized into 4 thematic areas of Population Dynamics & Reproductive Health, Urbanization and Wellbeing, Health Challenges and Systems, and Education.

This program continued its fellowship program where the Center hosted 7 postdoctoral fellows, 8 pre doctoral interns and 2 visiting scholars.

The program supported 17 new doctoral students drawn from several universities in Africa under the African Doctoral Dissertation Research Fellowships. This brought the total number supported by the program to 80 students since its commencement in 2008.

The Consortium for Advanced Research Training in Africa (CARTA) which is an initiative involving 9 African universities, 4 African research institutes, and selected northern partners now has 39 students. Through the program, we were able to

- initiate a model collaborative doctoral training program with strong supervision and mentoring components
- strengthen infrastructure, skills & faculty commitment to lead & manage research initiatives within the institutions
- contribute to the improvement of environments at African universities with the aim of facilitating and motivating researchers to stay and contribute to scholarly work within the region.

APHRC & the University of Witwatersrand, Johannesburg (South Africa) are jointly leading CARTA.

4b (Code:) (Expenses \$ 2,334,107 including grants of \$ 894,319) (Revenue \$ 0)**Population Dynamics Theme**

Population Dynamics mission is to provide scientific evidence and articulate policy and program priorities for sustainable population growth and improved sexual and reproductive health in the region.

Major programs under the theme include:

1. Measurement, Learning & Evaluation (MLE) of the Urban Reproductive Health Initiative in Senegal, Nigeria and Kenya where large surveys are being carried out in major cities of these countries to evaluate programs being implemented. This project is ongoing.
 2. Evaluation of a set of interventions on improving the delivery and uptake of family planning in Western Kenya with the aim of reversing the stall of fertility decline in this particular region.
- Impact: A noticeable expansion of community health workers' activities and a strong involvement of the Ministry of Public Health and Sanitation at the national, provincial and district levels.
3. Masculinities, wellbeing and civic engagements in the slums of Nairobi which sought to understand how economic difficulties and urban poverty stress shape relationships, health and wellbeing, and civic engagements among slum men in Nairobi, Kenya

4c (Code:) (Expenses \$ 1,008,742 including grants of \$ 0) (Revenue \$ 0)**Education Theme**

The theme's mission is to contribute to the achievement of sustainable and quality universal basic education in sub-Saharan Africa and influence policies that enhance best education practices for improved schooling and learning outcomes.

In 2011 assessing how poor and non-poor urban households have responded to Kenya's free primary education education and quality of classroom learning in testing teachers' subject and pedagogical knowledge studies were completed.

Findings - Nearly 60% of slum residing pupils are not enrolled in government schools.

Impact - Through our research Kenyan's Ministry of Education has now recognized the importance of considering household socio-economic conditions in its policies. It has also instituted measures to support non-formal schools in poor urban areas in which most children living in slum are enrolled

Findings - Many teachers are not adequately prepared to handle math and their classroom teaching styles do not encourage 'independent learning and critical thinking' among low-performing pupils.

Impact - Ministry of Education pledged to consider teacher-subject specialization in improving learning outcomes.
