FOR THE YEAR ENDED DECEMBER 31, 2011

1. Afula Educational Center, Inc. was incorporated in the State of New York as a 501(c)(3) non profit organization.
2. The financial statements have been prepared on an accrual basis, however, whereas there are neither pledges receivable nor payables the accrual method equals the cash method of accounting.
3. The organization follows the Statement of Financial Accounting Standards (SFAS) No. 117, "Financial for non-profit Organizations." Under SFAS No. 117 the Organization is required to report information regarding its financial position and activities according to three classes of net assets: unrestricted net assets, temporarily restricted net assets, and permanently restricted assets. The organization also follows SFAS No. 116, "Accounting for Contributions Received and Contributions Made". In accordance with SFAS No. 116, contributions received are recorded as unrestricted, temporarily restricted, or permanently restricted support, depending on the nature of any donor restrictions. The donors did not make any restrictions on funds donated thus, all contributions received are categorized uniformly and fund balance consists only of unrestricted net assets.
4. Unconditional promises to give are recognized as revenues in the period received and as assets, decreased of liabilities, or expenses depending on the form of the benefits received. Promises to give are recorded at net realized value if expected to be collected in one year and at fair value if expected to be collected in more than one year. Conditional promises to give are recognized when the conditions on which they depend are substantially met. There are no outstanding promises to the organization as of December 31, 2011 therefore, no receivable exists.
5. The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.
6. The organization is unaware of any contingent liabilities. There are no lawsuits pending against the organization.
