Reasonable Cause for late filing Form 990

Bragg Jam, Inc. (the Organization) is an exempt organization under Internal Revenue Code 501(c)(3) and is staffed entirely by volunteers. Between 2010 and 2014, the Organization experienced significant transition in its volunteer leadership and those responsible for maintaining the accounting records. The Treasurer position changed each year. In addition, due to a change of address, the Treasurer did not receive bank statements for a series of months. The new Treasurer needed time to become acquainted with non-profit accounting, federal and state regulations. In addition, during 2011, the Organization greatly expanded the operation of its annual fundraising event. The combination of these factors within the same time span resulted in hardship with respect to accurate bookkeeping and timely tax reporting.

Internal Revenue Code Sections 6652 and 7207 mandate significant penalties for knowingly filing an incorrect tax return. The Organization postponed filing the 2011 Form 990 until the Organization's officers could recruit and hire an experienced bookkeeper. This was necessary to ensure accurate tax reporting. The late filing of this return was unfortunate, but unavoidable. We respectfully request that the IRS waive any penalties assessed as a result of the late filing.
