	The Centre Pompidou Foundation fosters dynamic exchanges of ideas through special events, exhibitions, and trips. The Foundation also publishes catalogues, translations, and other scholarly materials. The Foundation maintains a special link with the Centre Pompidou in Paris providing cross cultural activities. Millions of people view the art at Centre Pompidou.

Since 2005, the Foundation's mission has been successfully accomplished through the increase in scope of its collections from \$ 1 2 mm of value at the end of 2005 to \$15 75 mm at the end of 2011. This increase was largely achieved through major gifts of art such as Jean Prouvé's Tropical House, Chuck Close's Arne, Hannah Wilke's S O S Stanification Object Series, Robert Gober's untitled sculpture, David Smith's untitled works on paper and Richard Avedon photos. The Foundation's collection is on long term loan to the Centre Pompidou.
