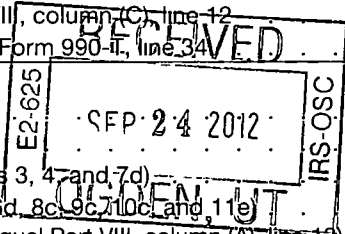

NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2011

NOTE 1 - NATURE OF ORGANIZATION

Lincoln Hospital Auxiliary, Inc. (the "Auxiliary") was incorporated under the laws of New York State on August 7, 1957. The Auxiliary is a nonprofit organization providing services to enhance patient care at Lincoln Medical and Mental Health Center (the "Facility").

The Auxiliary is exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code. The Auxiliary's primary source of revenue is commission income.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting - The financial statements are prepared on the accrual basis of accounting.

Use of estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Certificates of deposit - Certificates of deposit have maturity dates of more than three months and are considered investments for the purpose of cash flow reporting.

Investments - Investments are stated at fair value. The Auxiliary invests in various investment securities. Investment securities are exposed to various risk such as interest rate, market and credit risks. Due to the level of risk associated with investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term based upon the markets' fluctuations and that such changes could materially affect the Auxiliary's financial statements.

Commissions receivable - Commissions receivable are recorded when earned. Interest is not accrued or recorded on outstanding receivables.

Allowance for doubtful accounts - The Auxiliary determines whether an allowance for uncollectibles should be provided for receivables. Such estimates are based on management's assessment of the aged basis of the receivable, current economic conditions, subsequent collections, and historical information. Receivables are written off against the allowance for doubtful accounts when all reasonable collection efforts have been exhausted. Bad debt expense is charged if the receivable is determined to be uncollectible based on periodic review by management. Management has determined that no allowance is necessary as of December 31, 2011.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Reclassification - In-kind contributions and audit fees of \$6,500 were recorded for 2010 to conform with the 2011 presentation.

Unrestricted net assets - Unrestricted net assets are those assets which are not restricted by donors or for which the donor-imposed restrictions have expired.

Commission income - Commission income are revenues from the gift shop, cafeteria and parking facility, and are recorded when earned, based on concession sales.

Contributions - Unconditional contributions, including promises to give cash and other assets, are reported at fair value at the date the contribution is received. The Auxiliary reports gifts of cash and other assets as restricted support if they are received with donor stipulations that limit the use of the donated assets. When a donor restriction expires, that is, when a stipulated time restriction ends or purpose restriction is accomplished, temporarily restricted net assets are reclassified as unrestricted net assets and reported in the statement of activities as net assets released from restrictions.

In-kind contributions - In-kind contributions are recorded at fair value at the date of donation.

Grant expense - The Auxiliary provides grants to Lincoln Medical and Mental Health Center, and other HHC Auxiliaries. Grant expenses are recorded when they are approved.

Functional allocation of expenses - Expenses are allocated among the program and supporting services based on the nature of the expense.

Fair Value Measurements and Disclosures

Fair Value Measurements and Disclosures establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below. Level 1 inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Auxiliary has the ability to access. Level 2 inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability. Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement. The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There has been no change in the methodology used at December 31, 2011.

- *Money market funds* - Valued at the closing price reported on the active market on which the individual securities are traded.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Auxiliary believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
