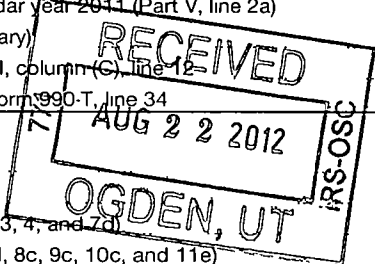

JOB TRAINING AND RETENTION INCLUDES OUTREACH, INTAKE AND ASSESSMENT, THE CORE ATTITUDINAL TRAINING, SKILLS TRAINING, JOB PLACEMENT AND RETENTION SERVICES AND TWO YEAR FOLLOW UP. THESE SERVICES ARE PROVIDED BY TRAINING STAFF, CASE MANAGERS AND JOB DEVELOPERS. OUR SKILLS TRAINING IN 2011 INCLUDED GREEN CONSTRUCTION, OFFICE OPERATIONS, A+ COMPUTER CERTIFICATION, AND MEDICAL BILLING. IN 2011, 338 COMPLETED CORE TRAINING AND 291 COMPLETED SKILLS TRAINING. WE PLACED 193 PEOPLE INTO JOBS WITH AN AVERAGE STARTING WAGE OF \$11.74/HR.

AS PART OF OUR JOB TRAINING AND RETENTION ACTIVITIES, WE HAVE A SPECIALIZED FATHERHOOD PROGRAM THAT WORKS WITH NON-CUSTODIAL FATHERS PROVIDING SKILLS TO ASSIST THEM TO RE-ENGAGE WITH THEIR CHILDREN. FURTHERMORE, WE PROVIDE JOB DEVELOPMENT SUPPORT AND ADVOCACY SERVICES TO HELP THEM INCREASE THEIR INCOME AND BEGIN TO MAKE CHILD SUPPORT PAYMENTS AT A PACE THAT IS SUSTAINABLE FOR LONGER TERM STABILITY. WE SERVED 82 PARTICIPANTS IN THIS PROGRAM IN 2011. IN ADDITION, WE SERVED 130 YOUTH IN OUR SYEP PROGRAM THROUGH NYC DYCD.
